1. The generic medical store in the campus should be given preference.
2. The drugs store in the campus with valid license under drugs & cosmetics act by Govt. Should be given first preference.
3. Medicine stores near the hospital within 200 mtrs. Radius will be considered and if no medicine store available within 200 mtrs. Radius, then beyond that medicine store will considered.
4. If any medicine to be procured is not available in the medicine store, it is the responsibility of the store to arrange it and supply it quickly.
5. It is applicable to persons below the poverty line, person with annual income not exceeding Rs. 50, 000 in rural area and Rs. 60, 000 in urban areas. Either BPL card or annual income certificate issued by concerned Tahasildar may be accepted for determining the eligibility.
6. RSBY card holder is also eligible under this scheme.
7. An unknown accident victim/ patients referred from registered destitute home / orphanage / mental asylum are also eligible for assistance under the scheme, subject to citing sufficient reason there of for recommending the patient under the scheme.
8. The central government / State government / P. S. U. Employees are not eligible.
9. Assistance will not be available for reimbursing the expenditure incurred by the applicant. The date of application seeking financial assistance should be during the course of treatment.
10. Re- imbursement of medical expenditure already incurred for treatment / operation shall not be permissible.
11. Diseases of common nature and disease for which treatment is available free of cost under other health programmes / schemes will not be eligible for grant.
12. Assistance will normally not be provided where medical coverage under ESI, CGHS or any other scheme is available or where there is a provision for reimbursement of cost of medical expenses.
13. Any person shall be assisted once in a financial year. Repeat assistance for the same ailment shall not be allowed in any case. However this will not be a bar for receiving the treatment assistance in phased manner for diseases like cancer, collagen disease, renal failure etc.
14. He will render 24X7 services on the spot.
