TENDER/QUOTATION CALL NOTICE

Sealed Quotation/Tender are invited from Travelling Agencies/Registered firms/Persons for providing four wheeler(Light Vehicle) to ICDS, Project, Bhograi- R for use in Official works on daily rent Basis. The details Terms/Condition are mentioned below.

1. The Vehicle must be in Road worth condition & must have valid Registration Certificate, Insurance, Fitness, Valid contact Carriage permit and up-to-date Tax paid etc which are mandatory for plying of vehicle.
2. The office shall not be responsible for any damage/loss caused to hired vehicle/loss of life/injury made to any person damage to any property on account of use of hired vehicle any manner what so ever. The hirer shall not be responsible for any litigation.
3. The hire charges will be paid in monthly basis in final but does not include cost of diesel, which is to be paid separately basing on actual consumption of fuel and lubricants as per existing Govt. norms. All the expenditure of the vehicle towards repair, replacement of spare parts, lubricant oils, Gear box, coolant, Tyres & Tubes, Battery etc. Will be borne by the bidder.
4. It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the owner.
5. In case of breakdown for reasons what so ever the replacement of a vehicle of the same or better model shall be provided by the owner of the bidder.
6. In case of the vehicle do not report regularly, the authority will be at liberty to reject the agreement and may engage vehicle from other source.
7. In case of emergency, the driver will have to report for duty as per the requirement of hirer. No extra payment shall be demanded.
8. Daily hire charges and reimbursements towards cost of diesel(as per actual and lubricants(as per Govt. Norms) of selected bidder will be paid in every succeeding month, as per possible within fifteen days of the submission of bills by the service provider and no advance payment will be made.
9. In case the service provider intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal of service and termination of agreement.
10. A sum of Rs.5000/-shall be deposited by the intending bidders in shape of Account payee Bank Draft drawn in favour of CDPO, Bhograi (R)& submitting along with the tender as security deposit. After completion of tender process the amount will be refunded to unsuccessful bidders.
11. Monthly basis charge be quoted separately in the general bid information(excluding fuel and lubricants)
12. The details of the make and year of manufacture of the vehicle, Registration no, Mileage (Kms covered per litre)& name of the driver with driving licence no .and period of validity should be specifically provided in the general bid information to be furnished with the tender.
13. If the bidder violates any of the terms of contract, Government shall forfeit the entire amount of security deposit.

14. The undersigned reserves the right to accept or reject any all or tender without assigning any reason thereof.
15. The vehicle shall not be more than 03 years old from the initial registration and also in good running condition during the period of contract.

The Quotation should be reached to the undersigned on or before 03.09.2018^{5 PM.} and the Quotations will be opened 04.09.2018 at about 3 PM at the office premises.
