Sealed tenders are invited from the eligible bidders as per the eligibility criteria for **medical equipments of Balasore District.**

1. The bidders have to submit their tenders in separate sealed covers (i.e. Cover "A"-Technical Bid & Cover "B"- Price/Financial Bid). Both the covers should be put into a third Cover "C" which must be super-scribed as "Tender for supply of medical equipments for NCD".
2. The Cover "A" (Technical Bid) for medical equipments should contain as follows:

- 1) Checklist with details of the documents enclosed in Cover "A" (as per Annexure - I) with page number. The document should be serially arranged with signature as per this Annexure - I and should be securely tied and bound.
- 2) Manufacturing unit / supplier / Dealer/Firm/Agency /company who has been blacklisted either by the Tender inviting authority or by any state Govt. or Central Govt. organization, is not eligible to participate in the tender.
- 3) EMD Rs.10,000/- (Rupees Ten Thousand only - Refundable) in shape of Bank Draft / Bankers Cheque in favour of ZILLA SWASTHYA SAMITTEE, BALASORE payable at Balasore.
- 4) Tender Paper cost of Rs. 500/- (Five Hundred) in the shape of a Demand Draft as non-refundable in favour of ZILLA SWASTHYA SAMITTEE, BALASORE payable at Balasore.
- 5) List of Item (s) Quoted individually in the prescribed format and items are quoted as per the technical specification. (Annexure - II).
- 6) Copies of organization PAN.

3. The Cover "B" (Price Bid) for medical equipments should contain as follows:

- 14) Financial Bid must be submitted in the prescribed format as attached in Annexure- IV. No other document should be enclosed in the Financial Bid. The Financial Bid should be sent in a separate sealed cover called Cover "B" (Price Bid).
- 15) If there is difference between figures & words, words will be taken into consideration.
- 16) If no suitable bidder found, committee may finalize the tender with suitable modifications and may relax any of the terms and conditions.
- 17) For any dispute decision of Collector and District Magistrate, Balasore shall be final.
- 18) All disputes are subject to Balasore jurisdiction only.
- 19) The undersigned reserves the right to reject or cancel any or all the tenders without assigning any reason thereof. Undersigned will not beresponsible for any postal delay.
- 20) Bidder should quote the rate of the items including all accessories and transportation cost subject to full fill all conditions with GST rate extra.
- 21) Tender rate contract is valid for one year from date of approval.


