



- 1.1 The Manufacturers/Regd Reputed firm/ Regd. Dealer/ Regd. supplier can participate in the bid.
- 1.2 The materials shall be as per the specifications only as mentioned in Quotation Schedule and strictly in accordance with relevant ISI specification.
- 1.3 GST and other taxes and duties ( In % ) if any should be mentioned separately. The quotationer should attach attested true copies of valid GST Registration Certificate & PAN card along with their offers.
- 1.4 The quotationer should quote single rate for the item. More than one rate for a particular item will be summarily rejected. The Schedule appended to Quotation Call Notice should be filled up and signed. No other Annexure than the schedule will be entertained.
- 1.5 The rate quoted by the successful quotationer shall be valid for a period of one year from date of issue of the supply order.
- 1.6 The rate should be mentioned in both figures and words. Incase of dispute rate in words will prevail over than in figure.

## 2 INSTRUCTIONS TO TENDERER :

- 2.1 The tender received after the last date shall be rejected automatically.
- 2.2 If the envelope is not sealed and marked as instructed, District Aahaar Society, Balasore assumes no responsibility for the misplacement or premature opening of the contents of the proposal submitted and such proposal may at the discretion of Tender Committee be rejected.
- 2.3 To verify the tenderer qualifications, District Aahaar Society, Balasore would strictly go by the documents asked as proof against each qualifying Criteria, which must be submitted with the tender. Any post-submission would not be considered.
- 2.4 Proposals of only those tenderers would be evaluated further who meet all the above Eligibility Criteria.
- 2.5 To facilitate evaluation of proposals, District Aahaar Society, Balasore at its sole discretion may seek clarification in writing from any Tenderer regarding its proposal.
- 2.6 All the necessary documentary proof with respect to above mentioned parameters should be submitted for consideration of the Tender Committee with the tender.
- 2.7 Tenderer's experience of supplying similar vehicle and instruments to any Municipal corporation and any Govt. Deptt. / Agency / PSU in Odisha / India shall be criteria for evaluation, besides rates quoted. The information & documentary proof for same should be provided with the Tender along with satisfactory Certificate of the Corporation using similar machines from the vendor/company.
- 2.8 The tenders will be opened in the presence of tenderers or their authorized representative who may wish to be present at the time of opening of tender.
- 2.9 The firm should also give the address of its nearest service centre and the time limit in case of any fault / breakdown of the vehicle. ( IMPORTANT)

- a. The vehicle shall be guaranteed for a period of 12 months from the date of purchase. The firm shall be responsible for any replacement / repairs during the warranty period free of cost and within shortest possible time.
- b. The delivery period should be clearly mentioned in the offer and should not be more than 10 days
- c. **Waive any minor informality or non-conformity or irregularity:** District Aahaar Society, Balasore may at its sole discretion may waive any minor informality or non-conformity or irregularity in a proposed document, which does not constitute a material deviation, provided such a waiver does not prejudice or affect the relative ranking of any Tenderer.
- d. **Conditional offers by the Tenderers:** The Tenderer should abide by the terms and conditions specified in the document. If tenderer submit conditional offers it shall be liable for outright rejection.
- e. **Modification and Withdrawal of offers:** Modification or Withdrawal of offers is not permissible after its submission. If the offer is withdrawn before the validity period, the EMD will stand forfeited.
- f. **Clarification of offers:** To assist in the scrutiny, evaluation and comparison of offers, the District Aahaar Society, Balasore may at his discretion, ask some or all vendors/ tenderers for clarification of their offer. The request for such clarification and the response will necessarily be in writing
- g. **The authority have rights to accept any proposal and to reject any tender or all Tenders:** Notwithstanding anything stated herein, District Aahaar Society, Balasore reserves the right to accept the tender or reject any tender, and to cancel the tendering process and reject all tenders at any time before the award of the contract, without assigning any reason.
- h. **Signing of Tender Offers:** The original copy of the Tender offer shall be signed by the Tenderer or a person or persons dully authorized in writing to bind the Tenderer to the Contract. Such authorization shall be indicated by authorization letter, accompanying the Tender offer. 
