1. The quotationer shall submit valid (i) GST clearance certificate Photo copy (ii) I.T. return 2018-19 (iii) PAN photo copy.
2. The maximum price cost for per wall painting (size ; 8' X 5'.6") is Rs.1000/-
3. All painting should be completed within 15 days from the date of issue of Order.
4. Sealed quotation will be received in the office of the ICDS, Project Khaira during Office hours on working days only from dt;7.1.2019 to 21.1.2019 (both days inclusive).
5. The last date for submission of quotation is 21.1.2019 by 5 P.M. and the quotations will be opened on dt; 22.1.2019 at 11.00 A.M. in the Office of the undersigned in presence of the committee members and quotationers/ their authorized agents.
6. The committee reserves the right to accept, reject any or all quotations without assigning any reason thereof.
7. The quotationer has to deposit Rs. 1,000/- (Rupees One thousand)only as security money in shape of cash/ Bank Draft in the Office of the CDPO, khaira & obtained money receipt from that. The Bank draft will be prepared in favour of CDPO, Khaira.
8. The security deposit amount of un-successful quotationers will be refunded on or after 22.1.2019 but the security deposit amount of the successful quorationer will be locked till completion of wall painting subjected to forfeiture in case of non-completion of wall painting within the stipulated time limit.
9. Payment will be released only after completion of wall painting.
10. No advance payment will be made for the purpose.
