

Sealed quotations in plain paper are invited intending bonafide Suppliers/Manufacturers/Agencies/Firms excuting works for supply of **18 Standing Air Conditioners** with accessories on hire basis for fixing in the Counting Hall located inside the EVM/VVPAT Warehouse for Counting of Votes in connection with Simultaneous General Election to Lok Sabha and State Legislative Assembly,2019.

Intrested firms are required to submit their proposal in sealed envelops as per detailed instructions. Moreover, submit the **hire charges for per Standing A.C per day** in the proposal of the quotation.

The sealed envelops containing the proposals must be delivered to the District Election Office,Balasore by Post on or before **3.00PM on 07.05.2019** and quotation will be opened at **4.00PM** of the same day in the Office Chamber of undersigned.

Each Quotation is required to deposit EMD amounting to **Rs.5,000/-**(Rupees five thousand) only in shape of Bank Draft/Demand Draft in favour of Dy.Collector Election, Balasore payable at **SBI Main Branch,Balasore**. The quotation paper without cost of EMD will be summarlily rejected. The EMD of unsuccessful bidder/quotationers will be refunded on the day of finalization of quotation.

Photocopy of PAN Card/Photo Copy of GST/No dues Certificate from Income Tax Deptt. and clearance of any other tax dues up to **31.03.2019** should be furnished along with quotation papers other wise quotation will not be taken in to consideration.

The Quotationer will be required to fix **18 Standing Air Conditioner** with accessories in the Counting Hall located inside of the EVM/VVPAT warehouse within **5days** from receipt of the supply order.

The EMD of the selected firm will be realeased only after satisfaction of the execution of work order/performance.

In case of failed to installed the required nos of A.Cs with accessories as per specifcatrion within stipulated period then the EMD for the quotationer will be forfeited and criminal liability as per election rule will be fixed.

The price quoted in the quotation will exclude the GSTIN.

The transportation and fitting of all Standing Air Conditioners with accessories in the counting hall located inside of the EVM/VVPAT Warehouse, Balasore and the cost of the transportation shall be borne by the quotationers.

The undersigned reserves the right to accept and reject any or all the quotations without assigning any reasons thereof. He also reserves the right to increase or decrease the quantity of A.Cs with accessories and execution of works. The decision of undersigned shall be final.






