

All other terms & conditions as envisaged in the aforesaid tender notice No.140 Dt.10.10.2019 remain unchanged.



Terms and Condition for Supply of Sports Goods to Incharge, Sports Hostel, Balasore for the year 2019-20

Terms and Condition

1. Sealed tenders are invited from the interested bidders for supply of the items of given specification as provided in Short Tender Notice Vide **Order No. 140 Dt. 10.10.19**.
2. The last date for received of Tender paper is **Dt. 29.10.2019 upto 3.00 PM** only through Speed Post and Registered Post in the Office of District Sports Office, Balasore.
3. The Bidder will provide Technical and Financial Bid in two separate sealed envelopes (must be specified clearly at the top of the envelope). The financial bid of those bidders shall be open to qualify the Technical Bid.
4. The Bidder will enclose self attested copies of PAN and up to date valid GST Registration and GST Clearance Certificate form of financial year i.e 2018-2019 issued by the Competent Authority.
5. The Bidder are required to deposit EMD of an amount of Rs.5000/- (Rupees Five Thousand) only in shape of Demand Draft in favour of "Incharge, Sports Hostel, Balasore" payable at Balasore.
6. The Bidder are also required to deposit Non-refundable processing fees of Rs.500/- in shape of Demand Draft in Favour of "Incharge, Sports Hostel, Balasore" payable at Balasore.
7. The Bidder/ Representative will come along with the Sample of Prescribed Brand of each item in a closed cover/ container with signature on its sample.
8. The rate quoted by the Bidders should be inclusive of all taxes and transportation charge and will be valid till Dt.31.03.2020.
9. The Bidder shall provide an undertaking to the effect that he has capacity to supply all quoted items within 15 days for receipt of Supply Order and another Certificate to the effect that he has not been black listed by any Institution/ Organisation/ Government Department.
10. Non compliance if any of the above clauses will lead for rejection and forfeiture of EMD as required and L2 will be consulted for supply of items if the L1 bidder does not comply timely delivery of the quoted items.
11. The Bidder will provide copy of the authorisation issued by the manufacturer along with the Technical Tender Paper.
12. The authority reserves right to accept, amend, alter, modify and reject the Tender Process without assigning reason thereof.
