### A. TERMS AND CONDITIONS OF TENDER FOR TENTAGE & ALLIED WORKS

1. The firm/agency should have executed similar nature works of at least Rs.20.00 lakhs per annum in the last three financial years. Out of that the firm/agency should have executed at least one single work order of more than Rs.8.00 lakhs of Government departments/agencies /corporations within last three financial year.
2. The bidders should have registered his firm/agency under GST (GSTIN) & Income Tax (PAN/TAN).
3. The rate offered by the firm shall be inclusive of all taxes and duties.
4. The duration of the exhibition will be for 06 days. In case of any extension of Mela period, no extra payment will be entertained for the additional days. The venue shall be made available to the contractor by ORMAS before 8 days of commencement of the exhibition. All the desired works should be completed at least one day before the scheduled date and time of the inauguration of exhibition and should be handed over all the works as per specification, to the in-charge of exhibition.
5. The bidder shall quote their price for all the items without leaving blank. If found so, the bid will be treated as non-responsive and to be rejected.
