TENDER CALL NOTICE

Sealed tenders are invited for supplying following items to the Odisha Blood Bank, District Headquarters Hospital, Balasore as per the terms and conditions noted below.

TERMS & CONDITIONS

- 1 The tender form can be downloaded from the website i.e. www.baleswar.nic.in. The tender should accompany with DD in favour of "BLOOD BANK OFFICER, BALASORE" payable at Balasore for Rs. 2,000/- as tender fees.
- 2 Tender should be sent in sealed cover to the Chief District Medical & Public Health Officer, District Headquarters Hospital, Balasore, by REGISTERED/SPEED POST with super scribed as "Tender for the supply of Blood Bank Reagents & Consumables / printing materials/ Refreshment of Blood Donor to the Odisha Blood Bank, Balasore, Odisha" by 05.00 PM on 30/12/19 and will be opened at 11.00 AM on 31/12/19.
- 3 The validity of the present tender for supply of the goods and consumables, quoted rate of the consumables and equipments will remain valid till the finalisation of the next tender.
- 4 The rates of the items should be quoted in Indian Rupees.
- 5 Each tender should be accompanied by EMD for Rs. 10,000/- (for reagents & consumables) and Rs. 5,000/- (for Printing Materials & Refreshment) in the shape of DD in favour of "BLOOD BANK OFFICER, BALASORE" payable at Balasore which will be refundable on expiry of tender or to the unsuccessful tenderer.
- 6 Tender should be accompanied with GST Registration certificate.
- 7 The Dealers/Distributors are required to submit the copy of up-to-date Dealership/Distributorship certificate licence or valid certificate from Drugs Authority in favour of dealer to sale the product. The above EMD will be forfeited if a bidder (i) withdraws their bids during the period of bid validity or (ii) fails to perform the contractual obligations as per the purchase order.
- 8 Tender should be clearly written, legible and free from any erasure and overwriting. Each page of the tender should be **signed by the tenderer**.
- 9 In case of any item has been entered into a rate contract with DGS&D/EMP, a copy of the rate contract must be enclosed along with the tender.
- 10 The rate of GST as applicable, must be indicated in the tender separately along with rate of item.
- 11 Different brand for a single item from one tenderer / firm / dealer / company shall not be accepted and the tender will be rejected in case of violation.
- 12 Alternative price for any items not allowed, for which the tender will be rejected.
- 13 The tender will be opened on 31/12/19 at 11.00 AM in the presence of the tenderers or their authorised representatives. If they fail to attend at the time of opening of the tender it may not be taken as a bar for the authority/committee to carry out the tender process.
- 14 The selected Agency/Firm has to supply the requisite articles etc. within 15 days of receipt of the order without fail or else the supply order shall be treated as cancelled and the EMD amount shall be forfeited, order will be placed to L2/L3 as per following proper procedure.
- 15 The Authority may allow for a maximum period of one month after stipulated date of supply with penalty of 0.5% per week or part thereof of the purchase order value as liquidated damage charged for each, work-up to maximum of 2% of the value of goods.

- 16 Payment will be made after completion of delivery of entire order at the Blood Bank as per specification in good condition, otherwise payment will not be released.
- 17 The delivery should be made during working hours.
- 18 The bills for the goods supplied and other documents should be sent directly to the BBO, Balasore. The payment will be made to the supplier in shape of A/C payee cheque / NEFT.
- 19 The earnest money of successful tenderers will be retained by the Blood Bank, Balasore as security and the same will be forfeited in case of non-compliance of order, delayed supply, incomplete supply of order which hampers the work, deterioration of quality at any time, if not rectified after reminder or on violation of any other terms and conditions. The EMD of other approved firms/company will be refunded after finalisation of next tender.
- 20 The validity of the present tender for supply of the goods and consumables, quoted rate of the consumables and equipments will remain valid till the finalisation of the next tender. The original price of the product quoted by the firm will remain constant during this period and will remain in vogue till approval of next tender.
- 21 **Validity of the Tender Process :-** The tender process shall remain valid for a period of 120 days after the last date as specified in the tender.
- 22 **Authorisation from any company / manufacturer should be valid for participating in this tender.**
- 23 The contract shall be governed by and construed according to the laws in force in India and subject to exclusive jurisdiction of Courts of Balasore only.
- 24 The tender document should be numbered and arranged as per checklist.
- 25 Any effort by bidder to influence the purchaser/any member of the committee in its decision on bid evaluation or placement of purchase order may result in rejection of bidder's bid.
- 26 If any time during the period of contract, the price of tendered items is reduced or brought down by any law or act of the Central or State Government or by the tenderer himself, the tenderer shall be morally and statutorily bound to inform to the Chief District Medical & Public Health Officer, Balasore immediately about such reduction in the contracted prices. The CDM & PHO, Balasore is empowered unilaterally to effect such reduction as is necessary in rates in case the tenderer fails to notify or fails to agree for such reduction of rates.
- 27 In case of **Blood Bags**, following terms & conditions are to be followed :
- The dealers / manufacturer should enclose the certificate of analysis with indicating the sharpness of the needle.
- 28 In case of **Printing Materials** following terms & conditions are to be followed :
- The printing forms/registers/materials must be of good quality paper having GSM and size as per specification against the items. No inferior quality as well as smaller size paper will be accepted. The tenderer must enclose the sample copy of paper.
 - The printed materials must be as per the format and size (according to sample copy supplied) and the receipt book must be properly numbered.
 - The Samples for printing items are to be collected from the Office of the Odisha Blood Bank, Balasore
- 29 In case of **refreshment for Blood Donor** following terms & conditions are to be followed :
- The refreshment for blood Donor to be supplied in sealed pack individually from a reputed brand .
- 30 The acceptance of any tender or part of the same will be conveyed to the tenderer later date after approval by the purchase committee / Technical Committee.
- 31 The tenders are liable to be rejected if any of the above conditions are not complied with.
- 32 The CDM & PHO, Balasore reserves the rights to accept any tender in full or in part or to reject any tender without assigning any reason thereof.


