

Sealed quotations are invited from the interested Vehicle owners/Travels for engagement of their vehicle in the Mobile Veterinary Unit (MVU) in Khaira, Balasore Sadar, Remuna & Jaleswar Block of Balasore District on monthly hire basis from 01.07.2020 for one year as per the following terms & conditions. The quotations are to be received by the Block Veterinary Officer, Khaira, Remuna, Jaleswar & DD.V.H, Balasore Sadar on or before dt.29.06.2020 by 4.P.M positively. The vehicle will be engaged within the limited financial provision of Rs 30,000/-per month as communicated vide Director of Animal Husbandry & Veterinary Services, Odisha, Cuttack Letter No.9890(30),dt.16.06.20. The quotation must be accompanied with the Xerox copy of valid Registration certificate, Insurance certificate, Fitness certificate, valid contract carriage permit, proof of up to date tax payment etc.

1. The vehicle should be a TUV 300/Bolero/Sumo Gold (Preferably **BSIV compliant Petrol Vehicle**) in road worthy condition with modern fittings & shall not be more than three years old from the initial registration to dt.30.06.2020.
2. The vehicle should accommodate 3 persons with all need based equipment and materials. There should be sufficient space for keeping Equipment medicine, chemical, Biological etc.
3. A driver with valid license should be available as & when required. He should be a non-alcoholic person.
4. Vehicle should be kept clean and tidy condition and should have a clearly visible registration number in the vehicle.
5. Vehicle should be regularly serviced and maintained so as to avoid any break down. In case of break down an alternative vehicle should be arranged by the owner without compromising the services on Mobile Veterinary Unit.
6. Vehicle should have valid registration number & insurance.
7. Minimum average mileage is 10K.M.s per litre.
8. Agreement will be made with the vehicle owner and the driver should wear a badge with proper driving license.
9. The vehicle owner who disagrees for stickering of MVU vehicle, should not be allowed.
10. A GPS tracking system will be fitted in the vehicle.
11. The vehicle must be stickered front, back & side showing different departmental activities with blue coloured back ground.
12. In case of natural calamity like flood, cyclone, draught, lightening. Heat waves etc, different post mortem conduction of insured livestock & other livestock, for performing other departmental activities along with FMD-CP, THEILERIA-CP, Brucella-CP, PPR-CP & other CP programme MVU may move to serve the livestock & to help poor farmer within the limit of total fuel provision of Rs.10,000/- per month. The maintenance of hired vehicles shall be the responsibility of the owner of the vehicle including the change of lubricant.

13. Payment of monthly hiring charges including fuel cost will be made on availability of allotment from Director of Animal Husbandry & Veterinary Services, Odisha, Cuttack.
14. In no case vehicle will be allowed to remain outside headquarter village & town area.
15. The vehicle should be kept in owners custody.
16. The bidder can download the details about the tender from NIC Balasore website(www.baleswar.nic.in).




