

2. The tender should be accompanied with the following documents failing which the tender will be rejected.
  - a) Original tender paper duly signed on each page by the tenderer as token up acceptance of term and conditions of the tenderer
  - b) Attested copy of valid certificate issued from competent authority
  - c) Attested copy of PAN card/TIN/Income Tax clearance certificate either in the name of the firm/Agencies or in the name of its proprietor
  - d) Attested copy of recent VAT clearance certificate
  - e) The security deposit is fixed to **Rs. 10,000/-** to be deposited by successful tenderer in favour of the **CDPO, Bahanaga** in shape of **Bank Draft** of nationalized Bank. The same will be refunded after Audit of accounts.


