Term and Condition

- ❖ The agency / Firm/ NGO/ Contractor will lift daily generated household garbage from FMMCH, Balasore on daily basis in the forenoon within 11AM to 12 Noon.
- ❖ The agency / Firm/ NGO/ Contractor will provide a two wheel tractor iron dala which is to be placed empty in the containment area of a FMMCH, Balasore on daily basis.
- ❖ Garbage will be put in to the said iron dala and the agency will lift it for transfer to municipal land fill by a covered trolley .Similarly on that time the agency will provide another empty iron dala to containment area in readiness for generated next.
- ❖ Break down redress is the sole responsibility of the agency. At all points of time the agency will co-operate with the administration.
- ❖ Initial contract will be signed for a period of one year which can be extended/ renewed on a yearly basis up to 5 (five) years maximum with the same price basing on the satisfactory performance as certified by competent authority i.e. cleaning & sanitation committee .
- ❖ Non compliance to the assigned work as detected by the hospital authority, will lead to a notice of 15 (fifteen) days being served for rectification, failing which a new contract will be signed with L2/L3 agency and the security deport will be forfeited.
- ❖ Payment will be made on monthly basis on the 7th day of the subsequent month which is conditional to the satisfactory certification by the competent authority.
- ❖ The said party i.e. the agency shall at all points of time during continuation of the Agreement/ contract follow the laws applicable for the purpose of carrying out services for the first party i.e. Superintendent, FMMCH, Balasore.
- ❖ The second party shall provide and thereafter maintain insurance against all risk in respect to its property, staff and any equipment used for the execution of this contract.
- ❖ The outsourced agency shall be directly under the administrative control of the Office of the Superintendent, FMMCH, Balasore.
- ❖ If any disruption is found regarding lifting of garbage on a daily basis, in such cases @ Rs 1000.00 will be deducted from monthly total payment .
