AUCTION SALE NOTICE FOR CONDEMNED VEHICLE

In pursuant to letter No. 3888/Niz. Dtd. 27-05-2021 of Excise Commissioner, Odisha, Cuttack, it is hereby informed to all that the condemned Govt. Jeep attached to District Excise Office, Balasore bearing Registration No. OR-02J-3655, Mahindra & Mahindra Make Commander, Engine No. DW-118144 and Chassis No. DW-118144 shall be put to auction sale on dated 15-09-2021 at 4.00 P.M. in the Office Chamber of Superintendent of Excise, Balasore as per the following terms and conditions. The vehicle is kept in the campus of District Excise Office, Balasore. The intending bidders may inspect the vehicle in any working day during the Office hour i.e. 10.00 A.M. to 5.30 P.M., the upset price of the said vehicle has been fixed to and approved to Rs. 20,000/- (Rupees Twenty thousand) only.

Terms and Conditions :-

1. No Bid shall be accepted less than the upset price.
2. The intending bidder shall deposit Rs.1,000/- (Rupees One thousand) in cash towards caution money before the Inspector of Excise, Sadar Range Balasore on or before the date of commencement of auction. The caution money shall be refunded to the unsuccessful bidder immediately after the auction is over and in case of auction purchases, the amount shall be adjusted towards the approved highest amount.
3. The highest auction purchaser shall have to deposit the approved amount immediately after the auction is over in the Office of the Superintendent of Excise, Balasore. If he/ she fails to deposit the amount, the authority shall cancel the auction and he may put the vehicle on re-auction.
4. It is the responsibility of the auction purchaser to shift the said vehicle from the Office of the Inspector of Excise, Sadar Range, Balasore within three days, failing which ground rent @ Rs. 10/- per day shall be realized from him.
5. The auction purchaser shall take the vehicle along with the stepin and available tools.

6. The auction conducting authority reserves the right to reject any bid without assigning any reason thereof.
7. The more detail information shall be available in the Office of the Superintendent of Excise, Balasore in any working day during office hours.
