Sealed quotations / tenders are invited from interested Reputed (Travel Agencies / Tour Operators or Private individuals) for providing 01 (one) no of (Bolero / Sumo Gold / Ertiga / TUV-300) Diesel driven (AC) vehicles having sitting capacity not more than 10 (Ten) including driver, which shall conform to the Terms and conditions for Official use in **District Excise Office, Balasore** on monthly rent basis:-

TERMS & CONDITIONS FOR HIRING OF VEHICLE.


The following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on hire on monthly rent basis.

- 1) Tender inviting authority reserves the right of accepting or rejecting one or more tender offer(s) or cancelling the tender without assigning any reasons thereof.
- 2) Vehicles will ordinarily be deployed within the Balasore district and may sometime be deployed elsewhere within the State.
- 3) The vehicle must be in Road Worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc. which are mandatory for plying of vehicle.
- 4) The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
- 5) The Driver should be well behaved, gentle and obedient in nature.

- 6) A sum of **Rs. 5,000/-** (Rupees Five Thousand) only for each vehicle for which rate is quoted shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the Superintendent of Excise, Balasore, and submitted along with the tender documents as security deposit. After completion of tender process the amount will be refunded to unsuccessful bidders. In case of successful tenderers, the tender security will be converted to performance security. The performance security or security deposit is liable for forfeiture in full or part on violation of terms and conditions or on default to placing vehicle on being successful bidder.
- 7) The monthly rate of hire charge is to be quoted separately in the general bid information (Excluding fuel and lubricants).
- 8) The Vehicle must achieve a fuel efficiency of 10 or above K.M. Per Liter. The tenders quoting higher fuel efficiency i.e., more number of Kilometers per liter of fuel consumption will be taken into consideration along with the quoted hiring charges for deciding the cost effective tender offers. Other criteria and terms and conditions will be also be applicable for the same. Therefore, all such offers must fulfill the criteria as laid down in the terms and conditions, of this tender document.
- 9) The details of the make and year of manufacture of the vehicle, registration no., mileage (Kms covered per liter) and name of the Driver with Driving License No. and period of validity should be specifically provided in the general bid information to be furnished with the Quotation / Tender (**Annexure – III**).
- 10) The quotation completed in all respect should reach the undersigned on or before **09-09-2021** by **03.00 P.M.** and shall be opened on the same date at **4.00 P.M.** in present of the bidders or their authorized representatives.

11. The application form of quotation / tender containing General Bid Information & Terms and conditions for Hiring of Vehicles etc. will be available with the Head Clerk, Office of the District Excise Office, Balasore on payment of Rs. 100/- (Rupees One hundred) only from **dt. 26-08-2021** to **dt. 09-09-2021** or can be downloaded from Govt. website, <https://baleswar.nic.in> within the same period. In case the application form is downloaded from Govt. website, the applicant shall furnish a non refundable demand draft for an amount of Rs. 100/- (Rupees One hundred) only towards the cost of application along with the application.

12. All the stipulations and terms and conditions of tender documents and notice for hiring of vehicles, including the Annexure- III are applicable and must be adhered to. While submitting the tender offers, the tenderers also submit the signed copies of tender documents including the terms and condition in Annexure-II. The envelope containing the tender offer should be super-scribed "Tender Offer for Hiring of Vehicle" at the top of the envelope and name address and mobile number at the left corner of the envelope.

TERMS & CONDITIONS FOR HIRING OF VEHICLES

The stipulations and terms and conditions embodied in the tender document will form a part of the agreement.

1. The hired vehicle, during period of contract shall have all necessary valid MV documents such as : valid Registration Certificate, Insurance Certificate, Fitness Certificate, Pollution Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc. and D.L. of the driver available all the times. The Department / Office hiring the vehicle shall not be responsible for any damage / loss caused to hired vehicles or loss of life / injury made to any person or damage to any property on account of use of hired vehicle in any manner whatsoever. The owner / successful tenderer, whose vehicle is hired, shall be responsible for all such litigation. Salary of driver, repair and maintenance charges and other cost including taxes (except service tax on hire charges) shall be borne by the successful tenderers / service providers.
2. The hire charges to be paid for monthly basis is final but does not include cost of Diesel, which is to be paid separately basing on actual consumption and lubricants as per existing Government norms. All the expenditure of the vehicle towards repair, replacement of spare parts, Lubricating oil of Engine, Gear Box & differential Coolant, Tyres & Tubes, Battery etc. will be borne by the bidder.
3. It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the owner.
4. In case of breakdown for reasons whatsoever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle / successful bidder.
5. In case of the vehicle does not report regularly, the authority will be at liberty to reject the agreement and may engage vehicle from other source.
6. In case of emergency, the driver will have to report for duty as per the requirement of hirer. No extra payment shall be demanded.
7. Monthly hire charges and reimbursements towards cost of diesel (as per actual) and lubricants (as per Govt. norms) of selected bidder will be paid in every succeeding month, as per as possible within fifteen days of the submission of bills by the service provider and no advance payment will be made.
8. The vehicle shall not be more than 3 (three) years old from the initial registration and also in good running condition during the period of contract.

9. If the services are found to be unsatisfactory, the client shall give one-month notice and terminate the agreement.
10. In case the service provider intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal of service and termination of agreement.
11. If the bidder violates any of the terms of contract, Government shall forfeit the entire amount of security deposit.
12. This should be ensured by the Service Provider that the vehicles are kept under optimum running condition and avoid accidents attributable to lack of maintenance / upkeep. The hired vehicles cannot be used for any private / commercial purpose beyond office hours or during holidays.
13. Log books shall be maintained for the hired vehicles as in the case of Government vehicles. Kilometer reading and POL drawn shall be necessarily recorded in relevant columns and verified regularly by an authorized officer before making payment.
14. GST registration and GeM registration are compulsory for any Service Provider to provide hired vehicles to Government offices through GeM or through open bidding.
