QUOTATION CALL NOTICE

Sealed Quotations are invited from reputed registered Service providers/ Agencies having experience in providing services of Seasonal Workers to different offices/ organizations. The Regulated Market Committee, Nilgiri requires the service of 05 (Five) no of Quality Analysts of Paddy for smooth operation of paddy procurement during Khariff & Rabi season at different paddy procurement centers in Nilgiri & Oupada blocks. Service of 01 (one) no of watchman is also required for the e-NAM mandi at Ajodhya on outsourcing basis. The services of the personnel for Quality Analysts are purely temporary in nature and they shall be engaged only at the time of paddy procurement i.e. from the month of December, 2021 to March, 2022 and May, 2022 to June, 2022. The payment shall be made as wage rate fixed by the labour & E.S.I. Dept., Government of Odisha in respect of skilled worker. The personnel for Quality Analysts should be a ~~Master (AOT)~~ *Passed & above* and he must possess sufficient knowledge on quality of paddy. For the service of watchman the qualification is Class-VIII passed & the Service will be purely temporary basis and will be terminated at anytime without assigning any reason thereof. The payment to the service of Watchman shall be made as wage rate fixed by the labour & E.S.I. Dept., Government of Odisha in respect of un-skilled worker. The Candidates from home block with prior experience will be preferred and will be engaged in the same block. The bidders are required to submit rate of service charges as a percentage of total wages per month exclusive of G.S.T. no E.S.I. & E.P.F. shall be paid as the engagement is seasonal. The bidders are also to submit the documents related to their organization and send the same to ' The Secretary, Regulated Market Committee, Nilgiri, At-Kahalia, Po-Nilgiri, Dist-Balasore, Pin-756040 by registered/ speed post latest by 4PM of Dt. 10.11.2021. the sealed quotation will be opened on dated at 3.30 PM on Dt.11.11.2021 in the office of the Regulated Market Committee, Nilgiri in the presence of the Quotationers/ their authorized representatives. E.M.D. of Rs.1000/- (Rupees One thousand) only shall be deposited in shape of demand draft in favour of Secretary, RMC, Nilgiri payable at Nilgiri.
