1. 2. The tenderers have to enclose Bank Drafts Rs.3,000/- for the above vehicle in favour of Sub-Collector, Nilgiri payable at SBI Main Branch, Nilgiri as earnest money along with sealed tenders, without which the tender will not be accepted .
3. The vehicles can be inspected on any working day during the office hours from the date of publication of this advertisement in the premises of Res. Office of Sub-Collector, Nilgiri .
4. The Successful tenderer shall have to deposit 25% of the bid amount immediately after announcement on the spot and rest amount within 15(fifteen) days from the date of auction, failing which, the aforesaid deposit of earnest money will be forfeited and the vehicle will be put to fresh auction.
5. The approved tenderer should remove the vehicle within 15(fifteen) days from the premises after the date of full payment of the tender amount. The custody and safeguard of the vehicle beyond the period shall be the responsibility of the tenderer and no claim on that account shall be entertained.
6. On failure to remove the vehicle after full payment necessary ground rate @ 1 % of the tendered money shall be charged per day till the removal of the vehicle from the site .
