
The Quotation should be submitted in a sealed envelope super scribed in as " **Quotation for supply and installation of CCTV, Videography and Webcasting**" containing the quotation and must be delivered to the District Election Office, Collectorate, Balasore on or before 07.10.2020 by 1.00PM through Registered Post/Speed Post of Indian Postal Deptt. or dropped in the assigned box at the District Election Office, Collectorate, Balasore. The quotation received after stipulated date & time shall not be entertained. The quotation will be opened on the same day at 3.00 PM in the office chamber of the Addl. District Magistrate, Balasore. Quotationers of their authorized agency may remain present at the time of opening of Quotation.

TERMS & CONDITIONS OF THE QUOTAION CALL NOTICE

1. The intending supplying Agencies must be bonafide registered body having valid GST Registration No and IT return. Self attested photocopy of the registration certificate and IT return should be attached.
2. The Supplying Agency should have PAN and self attested copy of PAN Card should be attached.
3. The supplying Agency must not have been blacklisted by any Govt. organization (Attach declaration in stamp paper of rupees Ten)
4. The successful bidder will have to supply and install CCTV/Webcasting within 2(Two) days from the date of issue of supply order.
5. All the materials will have to be installed at designated location on their own cost. The transportation charges, loading and unloading of materials shall not be paid.
6. The quotationer **Shall deposit non-interest bearing earnest money of Rs.20000/- (Rupees twenty thousand) only** in shape of account payee Draft payable in favour of Dy.Collector Election ,Balasore which will be refunded to the unsuccessful quotationer of whose quotations are not accepted . The EMD of the successful quotations are not accepted. The EMD of the successful quotationer will be refunded after completion of the validity period.
7. If any dispute arises, the matter shall be referred to purchase committee for settlement of dispute.

8. The quotations received in incomplete form or after the scheduled date & time shall be summarily rejected.




