



Terms and Condition for Auction of Old and Unserviceable Vehicles

There are 19nos of Old and Unserviceable 108 Ambulances at (Annexure-1) and 9 old and unserviceable Govt. Vehicle to be put to auction for sale.

1. The old and unserviceable 19 nos of 108 Ambulances were located in different location which was mentioned in Annexure-1 against each. Similarly, the location of 9nos old and unserviceable Govt. Vehicle is in Annexure-2.
2. Interested parties/companies/individuals having GST registration, Pan Card may submit the quotation in a sealed cover by Regd. Post/Speed Post quoting the maximum price in Indian rupees to purchase vehicles over and above of the upset price fixed by MVI Balasore.
3. Quotations for sale parts of the vehicle will not be considered. The entire vehicle will be sold to the highest bidder "as is where is basis".
4. Interested parties can inspect the vehicle laying down in different location of the unserviceable vehicles, Prior to submit their Quotation/Bid.
5. The application fees of rupees 3000/- (Non-refundable) in the shape of Bank Draft in favor of ZSS Non-NRHM payable at Balasore O/o- CDM&PHO, Balasore should be submitted along with the application.
6. The Security money of Rupees 20,000/- (Refundable) in the shape of Bank Draft in favor of ZSS Non-NRHM payable at Balasore O/o- CDM&PHO, Balasore should be submitted along with the application. The security money is refundable within 30days from the date of Auction.
7. The last date of receipt of quotation in sealed cover by speed post/registered post is 15/04/2021. Quotation received after the last date will not be accepted for opening. The authority is not responsible for any postal delay.
8. The received quotation/bid will be opened on 16/04/2021 at 4pm in the office chamber of CDM&PHO, Balasore. The Bidder or their authorized representative may attended the opening of quotations/bid as scheduled.
9. The vehicle will be handed over to the successful tenderer after making the full payment of the accepted tender money.
10. The tenderer will remove the vehicle from the site within 07(seven) days of full payment. The safeguard and custody of the vehicles shall be the responsibility of the tenderer. No claim or complain in this regards shall be entertained by the undersigned.
11. Ground charge @1% of the tender money will be charged for each day or part of the day from the successful tenderer till the vehicle is removed from the site in case of failure to remove the same within the stipulated time period.
12. Where the ground charge exceeds the sale price deposited, the tenderer shall cease to have any right on the vehicle. The amount deposited by the tenderer will be adjusted towards the ground charge and the vehicle become absolute property of the Govt. from encumbrances and disposed of by fresh tender.
13. If the competent authority does not approve any tender, the amount deposited by the tenderer will be refunded without interest and acceptance of the particular tender will be null and void.
14. In case of highest quotation/bid value is more than one and equal, the transparent lottery will be held to finalize the auction process. The highest bidder will deposit the final value in the shape of Bank Draft in favor of ZSS Non-NRHM payable at Balasore O/o- CDM&PHO, Balasore within 7days from the date of auction after which the final bidder will not claimed in future.
15. On failure of production of Bank Draft towards value of auction sale of vehicle within 7 days and lifting the same within 30 days by the highest bidder. The security money will be forfeited. The further course of action will be decided by the auction sale committee.
16. Any dispute is subject to Balasore jurisdiction only.
