ORDER 27

Dated, Balasore the 23rd day of March 2022.

Tenders of plain paper in sealed cover are invited by the undersigned for sale of the departmental vehicle bearing Regd. No. OR-01-A-2437 (Diesel Ambassador Car "NOVA") Hindustan Motors make, pool car of the District Judge, Balasore. The upset price of which is fixed at Rs 18,000/- (Rupees eighteen thousand) only on "AS IS WHERE IS" basis. Each tender shall accompany a bank draft worth Rs 1,000/- (Rupees one thousand) only towards earnest money drawn in favour of the Registrar, Civil Courts, Balasore, payable at S.B.I., Main Branch, Balasore. The cover containing the tender shall be superscribed by the words "TENDER FOR OR-01-A-2437" and address to the Registrar, Civil Courts, Balasore and also contain the complete address of the tenderer. The tenders are to be sent by registered post or by hand so as to reach the address on or before 25.04.2022. The intending tenders having their proper identity proof may inspect the vehicle in the Civil Courts premises on any working day during office hour in presence of the Registrar, Civil Courts, Balasore. The sealed tenders shall be opened by the Registrar, Civil Courts, Balasore on 26.04.2022 at 11 A.M. in his office chamber in presence of the tenderers or their authorized agents. If that day be declared as Government holiday then the tender will be opened on the next day as per the schedule time. The bank draft shall be subject to refund immediately except in case of the highest tenderer whose offer is to be accepted.

The highest tenderer, whose tender will be accepted shall deposit 25% of the offered amount of the vehicle immediately after the same is confirmed and rest amount within 7 (seven) days from the date of acceptance of the tender. If he fails to deposit the bid amount within the stipulated period, the deposits (including the earnest money) shall be forfeited. The vehicle shall not be delivered to the tenderer until after full payment and compliance with the requisite formalities. Tools, implements and spare parts shall not be delivered with the vehicle. The successful tenderer shall remove the vehicle from the Civil Court premises within 7 (seven) days from the date of deposit of the full amount of the tenderer money. Custody or safe guard of the vehicle shall be responsibility of the tenderer and no claim or complaint on that account shall be entertained.

On failure to remove the vehicle within the time as aforesaid ground rent @ 1% of the tendered money shall be charged for each day or part thereof till removal of the vehicle from the site. If the ground rent so charged exceeds the sale price deposited, then the tenderer shall cease to have any right on the vehicle and the amount deposited by him shall be adjusted towards ground rent and the vehicle shall become absolute property of the Government.

The undersigned reserves the right to reject any or all tenders without assigning any reasons thereof.
