

The application form of tender containing General Bid information and terms and conditions will be available in the website www.baleswar.nic.in and can also be obtained from the Junior Accountant, Accounts Section, Office of the Divisional Forest Officer, Balasore Wildlife Division on transaction details showing payment of Rs. 1000/- (Rupees one thousand) only payable in favour of **DFO, Balasore Wildlife Division** towards participation cost/tender cost in the tender process. The Amount of Rs. 1000/- towards Tender Cost/Participation cost in the process is non-refundable. The Tender Documents downloaded from website and submitted must be accompanied by the deposit of Tender Cost of Rs. 1000/- (Rupees One thousand) in shape of Bank Draft, failing the bidding in tender process is liable for rejection.

The Tender will be received though online in email ID. dfo.balasorewl@odisha.gov.in only till 1.00 PM of 27.05.2022 and will be opened by the Tender committee of the Office of the Divisional Forest Officer, Balasore Wildlife Division on 31.05.2022. The result of the tender will be published on 01.06.2022 itself. ***If two or more valid Tenderers are in equal quoted rate then transparent lottery will be held on Dtd. 01.06.2022 at 11.00 AM in the office of the Divisional Forest Officer, Balasore Wildlife Division in presence of the contractor or their authorized agents.***

3. Valid Account Number with details of Bank of the contractor.
4. GST Clearance Certificate of the Contractor upto Last Quarters / Year.
5. Income Tax Return of Last three years of the Contractor.
6. Undertaking regarding completion of the works within the stipulated time decided by the Tender Committee.
7. Proof of Experience for carrying out similar works during last years
8. Proof of Single work order of value not less than 10.0 Lakhs, Two Job of Similar nature each of value not less than 5.0 Lakhs.


Terms and Conditions:

1. The Tender documents i.e. technical bid and financial bid should be submitted in separate sealed covers (Cover-1 containing Technical Bid and Cover-2 containing Financial Bid) through online/offline in the Tender Box in the Office in the prescribed format along with all relevant documents. During opening of the sealed cover, the sealed cover-1 i.e., the Technical Bid will be opened first. The name of those tenderers whose technical bid is successfully qualified in the scrutiny process by the scrutiny committee will be considered for financial bidding. The tenderers who do not qualify the technical bidding will not be considered for financial bidding.
2. The Tender Documents incomplete in any aspect is liable for rejection.
3. The Tenders received after the scheduled date and time is also liable for rejection.
4. The Price quoted is inclusive of all taxes as mandatory under Government of Odisha like GST, TDS etc.
5. The rate of successful bidder may be valid till next tender.
6. The undersigned reserve the right to reject/cancel any or all the tenders without assigning any reasons thereof and terminate the order in case of changes in the Government procedure of policy of instruction/ direction and exigencies.
7. The payment will be made through online mode after receipt of certificate of completion of work and physical verification of quantity and quality of the work by the Divisional Forest Officer, Balasore Wildlife Division or any officer authorized by him.
8. All legal disputes shall be subject to the jurisdiction of the Civil Court, Balasore.
9. The Contractors/Bidders must submit a willingness certificate for deposit of **1 % Bid security** of the amount specified to him after finalization of the works duly pledged in favour of Divisional Forest Officer, Balasore Wildlife Division.
10. Bid must be delivered through online in the Email ID specified in Tender Notice or in Box. In case of any unforeseen technical fault or through Courier/Speed Post etc., the Divisional Forest Officer, Balasore Wildlife Division will not be held responsible for any postal delay, if any, in the delivery of the documents or non-receipt of the same.
11. Bid documents must be accompanied with a deposit proof of Rs. 1000.00 towards participation cost.
12. Additional Performance Security shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender. In such an event only the successful bidder who has quoted less bid price / rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount as Additional Performance Security (APS) in shape of deposit in above account Number pledged in favour of Divisional Forest Officer within seven days, otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further, proceedings for black listing shall be initiated against bidder as per the Government of Odisha, Works Department Office memorandum, File No.07556900012013-14299/ dated 03.10.2017 of Amendment of Para 3.5.5 (v) of OPWD Code.

13. 1% (One Percent) of gross bill of the bidder will be deducted towards the labour cess over and above the usual deduction.
14. While making final payment of works 2% towards CGST & SGST and 2% TDS will be deducted from the gross amount to be paid.
15. If the rate quoted by the bidder is less than 15 % of the tendered amount, then such bid shall be rejected as per amendment of Appendix-IX, Clause-36 of OPWD Code Vol-II by inclusion.
16. If two or more valid Tenderers are in equal quoted rate then transparent lottery will be held on Dtd. 01.06.2022 at 11.00 AM in the office of the Divisional Forest Officer, Balasore Wildlife Division in presence of the contractor or their authorized agents.
17. Bid for the work shall remain open for acceptance for a period of 45 (Forty Five) days from the last opening of bids. If any Bidder/ Tenderer withdraw his bid / tender before the said period or make any modifications in the terms and conditions of the Bid, the said Earnest money shall be stand forfeited.
18. The Tender Committee, Balasore Wildlife Division reserve the right to reject all or any tender without assigning any reason thereof.
19. If the office happens to be closed due to any reason, the date of sale, receipt and opening will be made on the next working day at the same time.
