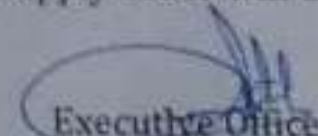

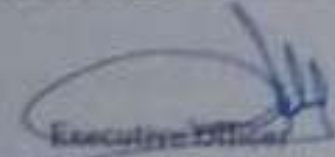

## TERMS & CONDITIONS

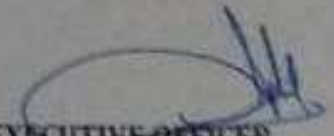
1. Reputed firm/ Dealer/ supplier can participate in the bid.
2. The materials shall be as per the specifications only as mentioned in Quotation Schedule and strictly in accordance with relevant ISI specification.
3. G.S.T and other taxes and duties ( In % ) if any should be mentioned separately. The Quotationer should attach attested true copies of valid G.S.T. Certificate, IT returns for last 3 years & PAN card along with their offers. Any other Govt Tax as applicable from time to time will be borne by the Quotationer.
4. The quotationer should quote single rate for the item. More than one rate for a particular item will be summarily rejected. The Schedule appended to Quotation Call Notice should be filled up and signed. No other Annexure than the schedule will be entertained.
5. The rate quoted by the successful quotationer shall be valid for a period of one year from date of issue of the supply order.
6. The rate should be mentioned in both figures and words. In case of dispute rate in words will prevail over than in figure.
7. **EMD** as specified in the above table in shape of Demand Draft /Bankers cheque duly pledged in favour of the **Executive Officer, Balasore Municipality, Balasore** shall be attached with the offers, which shall be refunded to unsuccessful quotationers in due course. No other mode of payment of EMD shall be accepted. Offers received without EMD shall be rejected out rightly. Request for exemption of EMD by any firm and adjustment for any previous deposits will not be entertained.
8. Paper Cost as specified in the above table with VAT shall be submitted in shape of **Demand Draft/ Bankers cheque** duly pledged in favour of " **Executive Officer, Balasore Municipality, Balasore**" which is non refundable. Offers received without Paper-Cost shall be rejected out rightly.
9. The quantity of materials specified in quotation schedule may be varied as per our requirements.
10. The materials should be supplied **within 10 ( Ten )** days from the date of issue of the supply order.

If the supplier fails to supply any item in time as per the supply order, Balasore Municipality will be liberty to purchase the required quantities from the open market at the cost and risk of supplier i.e. differential cost will be recovered from the supplier.
