Terms & Conditions

1. Tenderers willing to lease for the above mentioned resource for the upcoming time frame should record their highest price and deposit the entire amount simultaneously through bank draft along with the tender papers etc. Otherwise his tender will not be accepted.
2. If the person/entity who has taken the lease earlier, If could not deposit or has neglected to pay the previous auction amount, then that person/entity cannot participate in the said auction.
3. Interested tenderers shall send their highest price along with the prescribed amount of deposit along with bank draft at the Register post/speed post or in the tender box of the municipality within the stipulated time. No tender will be admissible after the prescribed deadline. Municipal authorities will not be responsible for postal delays.
4. The tender envelope shall mention the sources for which the tenderers have applied. Separate paper and envelopes should be used for resource.
5. The amount deposited in bank drafts paid by the unsuccessful tenderers will be refunded to the depositor through cheque. The persons/entities participating in this tender process and submitting the survey price may be considered for the lease for the next two financial years.
6. The tenderer shall strictly comply with the regulations issued by the Government of India or the Government of Odisha for obtaining the license. If the said leased resource is found necessary by the municipal authority, the amount paid by the highest bidder shall be refunded without interest and the resource shall be placed under municipal liability.
7. In no case shall the highest auction tender be acceptable below the minimum price fixed by the Municipality.
8. Municipal authorities are not bound to accept the highest tender price. The power to cancel the tender without assigning any reason is vested in the municipal authority. Therefore, the municipal authority is not responsible for paying any compensation.
