The tender will be held as per stipulated conditions. For the above purpose intending persons/associations/agency/firms/SHGs may submit their tender on or before 25.01.2023 up to 3.00 Pm. The above tender will be opened on 27.01.2023 at 3.00 Pm. before tender committee. During opening of tender, applicant or his/her authorized person may be present . If the said leased resource is found necessary by the municipal authority the amount paid by the highest bidder shall be refunded without interest and the resource shall be placed under municipal liability.


8- In no case highest auction tender shall be acceptable below the upset price fixed.


