- Other parts are fabricated with 25mm dia "B" Class Iron Pipe.
- All moving parts are fitted with sealed ball bearing for smooth operation.
- All metal portions are pointed with one coat of "Etch Primer" and two coating of "poly Urethane Coating" after treated for corrosion prevention.
- PU foam made handles or Grips are fitted.
- Equipments to be rigidly grouted on ground with concrete of rich mixture at ratio 1:2:4
