


2. The Bid documents will be available in the website : [www.tendersorissa.gov.in](http://www.tendersorissa.gov.in) from **10.00 Hours of 06.04.2023 to 16.00 Hours of 20.04.2023** for Online Bidding.
3. The Bidder must possess Compatible Digital Signature Certificate (DSC) of Class-II or Class-III
4. Bids shall be received only on **"On line"** on or before **16.00 Hours of 20.04.2023**
5. Bids received online shall be **opened at 11.00 Hours on 21.04.2023** in the office of the undersigned in presence of the bidders who wish to attend. Bidders who participated in the Bid can witness the opening of Bids after logging on to the site through their DSC . If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
6. The bidder shall transfer online the cost of bid document for Rs.10000/- towards cost of the Bid & Bid security mentioned in col-5 above through a process as mentioned under DTCN .
7. For a particular work a bidder can submit only one tender paper. Submission of more than one tender paper by a bidder for a particular tender will liable for rejection of all such tender papers.
8. Bidders are to submit only the original BOQ uploaded by publisher after entering the relevant fields without any alteration / deletion / modification .Multiple BOQ submission shall lead to cancellation of bid.
9. If the rate quoted by the bidder is more than 14.99 % less of the tendered amount then such a bid shall be relected.

10. Other details can be seen in the bidding documents.
11. The authority reserves the right to reject any or all Bids without assigning any reason thereof.
12. In case of the lottery required to be conducted among the successful bidder in accordance with the Works Deptt. Order No-10224 dated 01.09.2015, the same will be conducted at **suitable date** in the office chamber of the under signed. The Bidders are requested to keep in touch with this office and also requested to be present during the lottery as per the schedule date, time and venue. If the qualified bidder/bidders failed to attend the same will be conducted in presence of the available bidder and the result will be binding upon them.
13. The Engineer contractor willing to avail the Exemption of EMD will submit the original affidavit along with bid documents before opening of Bid. Affidavit should contain how many times such facility have been availed by him prior this during the current financial year. Otherwise they will not be entitled to avail such facilities
14. In the case of schedule caste/ schedule tribe contractors, Government undertakings, Co-operative societies, Diploma / Degree holders in Engineering who are registered with the Govt. of Odisha, the rules framed by Govt. from time to time about cost of Bid documents, Bid Security, Performance Security Price preference & other benefits will apply.
15. Subsequent corrigendum/Addendum if required shall only be available in web site indicated above.
16. As Goods & Service Tax (GST) has come in to force with effect from 01.07.2017, the rate quoted should be excluding GST as applicable.
17. The bidder shall transfer online the Earnest Money deposit/Bid Security of the amount specified for the work in the table col.5 above as part of its bid through a process as mentioned under DTCN Bidders desirous to hire machineries or equipments from outside the state or owned but deployed outside the state are required to transfer online 2 % of the amount put to tender as Bid security/Earnest money Deposit (EMD)./






