

1. The envelope carrying the bid must be subscribed in capital letter "OFFER FOR AUCTION SALE OF VEHICLE".
2. The intending tender may submit their offer in plain paper mentioning.
 - (a) Name and detail address of the tenderer.
 - (b) Amount and details of EMD deposited.
 - (c) Amount of price offered.
 - (d) Signature of the tenderer.
 - (e) Aadhaar Card & Pan Card (Xerox copy).
3. The intending quotationers are advised to inspect the above vehicle parked at place mentioned above between 9 A.M. to 12 P.M. from dt. **24.04.2023** to **10.05.2023** on all working days before submitting the quotation. Each quotation must accompany an earnest money deposit @10% of the offset price only in shape of Bank Draft which will be refunded to the quotationers whose quotations are not accepted except in case of the successful bidder. The bid price offered shall not be less than the minimum (upset) price as mentioned above in each case.
4. The quotation should reach in Office of the **Addl. Sub-Collector, Settlement, Balasore** by registered post/speed post and same should be dropped in the sealed tender box kept in the **Office Chamber of the Addl. Sub-Collector, (Settlement), Balasore** on or before dt. **10.05.2023** up to **10 A.M.** & the sealed quotations will be opened on dt. **10.05.2023** at **11 A.M.** by the undersigned. If this day is declared later as a Government holiday then the quotations will be received and opened on next working day as per the schedule time. The undersigned will not be held responsible regarding late submission / receive of quotation in any manner.
5. The vehicle shall not be delivered to the party until full payment is made and compliance with the requisite formalities.
6. The successful bidders shall take steps for change of ownership in his/ her favour consulting with the local R.T.O. after observing of all necessary official formalities.
7. The highest quotationer, whose quotation is accepted, shall have to deposit immediately **100%** of the offered amount in **Cash** immediately. If he/ she fails to deposit the same, his tender shall be cancelled & **EMD** be forfeited. Then, the **2nd** highest bidder having offer price above the upset price shall be considered and asked to deposit the amount. In case of non-availability of eligible quotationers, the tender will be called afresh on later date.
In case of same price offered by more than one tenderers, lottery will be drawn to dispose of the case among the tenders.

If the ground rent so charged, exceed the sale price deposit, then the quotationers shall cease to have any right on the vehicle and the amount deposited by him shall be adjusted towards ground rent.
