Each Quotation is required to deposit earnest money of Rs.24,000/- (Rupees Twenty-four Thousand) only which is 10% of the quotation amount in shape of Bank cheque in favour of Sub-Collector, Nilgiri payable at SBI Branch, Nilgiri. The quotation paper without EMD will be summarily rejected. The EMD of unsuccessful Bidders will be refunded in the day of finalization of Quotation.


