In pursuance of Odisha District Revenue Services (Method of Recruitment and Conditions of Services) Rules, 1983 and subsequent ammendment Rules made thereof, the following **35 (Thirty five)** candidates who have come out successfully in Combined Recruitment Examination (CRE)-2021 pursuant to advertisement No- III-E-121/2021-999(C)/OSSSC dt. 30.09.2021 conducted by Sub-Ordinate Staff Selection Commission, Bhubaneswar and subsequent instruction made thereof vide Letter No. IIE-63/2022/1978/OSSSC dtd. 07.12.2022 of Joint Secretary Sub-ordinate Staff Selection Commission are hereby temporarily appointed to the post of **Asst. Revenue Inspectors** in **Balasore District** on **regular basis** in Cell-1, Level-04 of the first schedule of the Pay Matrix under Odisha Revised Scale of Pay Rules, 2017 as per Odisha Group-"B", "C" & "D" posts (Repeal and Special Provisions) Rules, 2022 notified vide GA & PG Department Notification No- PT1-GAD-SC-GCS-0090-2022-29076/Gen dt. 16.10.2022.

They shall be on probation for a perid of 02 (two) years and their appointment is purely temporary and subject to the verification of character and antecedants. On receipt of adverse report on character and antecedants at any point of time during the said period, his/ her services shall be terminated forthwith in accordance with the provisions laid down in sub-clause (II) of clause (h) of Explanation under Rule-13 of the Odisha Civil Services CCA (Classification, Control and Appeal), Rules, 1962 reinforced in GA Department Resolution No- 34438/Gen dt. 20.11.1999.
