





With due respect I state that I have received your letter No:-^{1013²}~~912~~ Dt-30/10/2020 on 31/10/2020 at 8:20 pm and I am giving my clarification hereunder.

- 1) That, as per your letter No:- 718/Elec. Dt- 4/10/2020 regarding the Finalized Rate Chart for Bye Election to 38- Balasure A.C. in which no charges for booking Kalyan Mandap is mentioned but in your Shadow Observation Register shows Rs. 20,000 for booking of Kalyan Mandap. In fact, we are booking Kalyan Mandap at very low rate.
- 2) That, I have showed the expenditure towards Banner, Flags, Leaflets, etc. in my Cash Register. We are using the same Banner, Leaflets, Flags, etc. in various meetings one after another. But your Shadow Observation Register shows separate expenditure of Banner, Flags, Leaflets, etc. for separate meeting every time, that raises more expenditure in your Shadow Observation Register.
- 3) That, I filed my nomination on 15/10/20 and the day was a rainy day. So, I along with my few senior leaders walked down from Fandi Chhak to Sub-Collector Office without any rally or band procession. Whereas your Shadow Observation Register shows two numbers of nomination rallies.
- 4) That, all the meetings which were held between 18/10/20 to 24/10/20, no hiring charges for motorcycles and four wheelers were paid by me. The public who came to attend the meeting used their vehicles. But your Shadow Observation Register shows high amount of expenditure in this regard.
- 5) That, your Shadow Observation Register shows expenditure for Video Cassettes, Camera Cassettes and Camera man in almost all the meetings. But in fact, I have still not used such items in any of my meetings.

- 8) That, on meeting Dt:- 17/10/20 at Siddhi Kalyan Mandap, Balasore your Shadow Observation Register shows huge expenditure towards the meal i.e., Biryani and Soup. In fact, I had not distributed any meal on that meeting.
- 9) That, the above mentioned points may justify my clarifications and reconsolidate the understatement.
