Corrigendum to Advertisement No,3651,Balasore of 2023-24 dated.18/07/2023 for Tender Call Notice for Construction of ICT Education and Smart learning facility for the Boarder Students of SSD Pinchhabania under Panchayat Samiti, Sadar, Balasore.

It is for information of all concerned that:-

- The Detail Tender Call Notice 2023-24 (Annexure –A) an EMD @ 1% of the Tender cost i.e.Rs.12605/- is to be deposited by the Bidders in addition to the previous amount.
- In Sl. No.4 of Technical bid the plan & specifications for the work can be seen at Civil Engineering Section in the Office of BDO Sadar Block Balasore instead of NHM, Bls.
- In Sl. No.6 the 1st Paragraph is to be treated as below instead of previous one.

The bidder whose tender is selected for acceptance shall within a period of seven days upon written intimation being given to him of acceptance of his tender make an initial security deposit of 1% (One Percent) of Tender Cost. So that the earnest money and initial Security deposit will be total 2% (Two Percent) of the tendered amount as shown in clause 3 above and sign the agreement in the P.W.D. Form No. P-1 (Schedule XLV No. 61) for the fulfillment of the contract in the office of the BDO, SADAR BLOCK, Dist. Balasore.

d. In Sl. No.31 weight of Cement shall be used in bags and weight of one cubic meter of cement being taken at 14.2 quintals instead of 41, 42 quintals.

e. In Sl. No. 41 1% (One percent) of gross amount of the bill is to be deducted towards income tax from the contractor's bills instead of 3%(Three percent).
