6. Bid document consisting of qualification, information and eligibility criteria of bidders, plans, specification and bill of quantities of the works are available in web-site www.tendersorissa.gov.in and the set of terms and conditions of contract and other necessary documents can be seen in the web-site till last date and time of availability of tenders for bidding. Interested Tenderers may obtain further information at the web-site www.tendersorissa.gov.in.

7. The bids validity period of the tender is for a period of 90 days from the last date of receipt of bids. If any bidder / tenderers withdraws his bid / tender before the bid validity period or makes any modification in the terms and condition of the bid, if he fails to submit ISD as specified in instructions to bidder/if he fails to signed the contract for whatever the reason **they will be suspended for a period of three years.**

8. The bid must be accompanied with the “**Bid Security Declaration**” instead of EMD/ Bid Security in the standard format i.e. **Annexure-I** as provided in the **Section-2** of bid document.
9. Contractors exempted from payment of EMD also shall have to submit “**Bid Security Declaration**” as per **Annexure-I** of **Section-2** of Bid Document. The bids without “**Bid Security Declaration**” will be summarily rejected.
10. The bidder shall transfer the required amount of cost of bid documents & EMD as mentioned for the specify work in Col.4 & 5 of the above table by online through electronic payment mode like internet banking/ NEFT/RTGS of designated banks (SBI/ICICI Bank/HDFC Bank) and their Aggregator Banks as per WDOM No.17254 /W Dt.05.12.2017 as mentioned in DTCN.
11. **Additional Performance Security** (As per Works Department OM No.4559 dt.05.04.2021) shall be obtained from the bidder when the bid amount is less than estimated cost put to the tender. In such an event only the successful bidder who has quoted less bid price/ rates than the estimated cost put to tender shall have to furnish the Additional Performance Security as per the following rate.

The applicable Additional Performance Security (APS) shall have to be furnished by the successful bidder in shape of term Deposit Receipt pledged in favour of **Project Administrator, ITDA, Nilgiri** / Bank Guarantee in favour of the **Project Administrator, ITDA, Nilgiri** from any Nationalized/Scheduled Bank in India counter guaranteed by its local branch at **Nilgiri** within seven days of issue of Letter of Acceptance (LOA) by the **Project Administrator, ITDA, Nilgiri** (by e-mail) to the successful bidder otherwise the bid of the successful bidder shall be cancelled. Further, proceeding for blacklisting shall be initiated against the bidder. (*Vide Office Memorandum No.14459/W dated 20.09.2018 of Works Department, Govt. of Odisha*).

12. The original affidavit and no relation certificate should be retained by the bidder with him. The bidders have to furnish the original documents to the under signed as and when required for verification of the Tender. The successful bidder have to submit the original affidavit, No relation certificate, required APS amount and ISD amount to the undersigned before drawal of the Agreement.
13. If the rate quoted by the bidder is less than 15% of the tendered amount, then such a bid shall be rejected and the tender shall be finalized basing on merits of rest bids. But if more than one bid is quoted at 14.99% (Decimals up to two numbers will be taken for all practical purposes) less than the estimated cost, the tender accepting authority will finalize the tender through a **transparent lottery system will be held** in the office of the undersigned in presence of all bidders/their authorized representatives, the Executive Engineer & Divisional Accounts Officer.
14. The Schedule Caste/ Schedule Tribe/ Physically handicapped Contractors desiring to avail the facility of price preference or exemption of EMD is required to submit an Affidavit to this effect. The bidders have to furnish the original Affidavit and R.C. to the under signed as and when required for verification of the Tender. The successful bidder have to submit the original Affidavit to the undersigned before drawal of the Agreement.
15. A bidder can submit only one tender paper for a particular work, submission of more than one tender paper by a bidder for a particular tender will liable for rejection of all such tender papers as per Works Department Ltr. No.4985/W dtd. 28.03.07.




16. Only those bidders who successfully remit their Cost of tender Paper and Earnest Money Deposit on submission of bids would be eligible to participate in the tender/bid process. The bidders with pending or failure payment status shall not be able to submit their bid. Tender inviting authority, State Procurement Cell, NIC, the designated Banks shall not be held responsible for such pendency or failure.
