Office Of The Panchayat Samiti, Basta Odisha on behalf of the Governor of Odisha invites **percentage rate bids** through **e-Tendering** in conformity with the terms & conditions of the detail tender call notice(DTCN) in **single Bid** system from class of contractors as mention in col-06 of table registered with the state governments and contractors of equivalent class/Grade registered with Central Government / MES / Railways for the civil construction works requirements detailed given in the DTCN on **Percentage Rate Bids** to be eventually drawn up in **standard P1 contract Form**. The bid should be submitted on-line in the website www.tenderodisha.gov.in by eligible class of contractors. The bidders should have the necessary portal Enrolment(with his own digital signature certificate).The registered bidders of outside Odisha can also participate in this process, after necessary portal Enrolment, but shall have to subsequently undergo registration with the appropriate authority of the State Govt. before signing agreement.

1- Cost of Bid documents/Tender paper & EMD :-

Earnest Money Deposit should be paid Electronically through payment gateway of designated banks such as SBI / ICICI / HDFC bank for all Govt. Departments as per Office Memorandum No. 07679600032015-17276, dated 06.12.17 of Works Department, Govt. Of Odisha. A standard form is attached in DTCN. . EMD in any other form shall not be accepted. The bidder should remit the cost of Tender paper through NEFT/RTGS payments using internet payment of the bank in which the bidder holds his account by adding the account no. As mentioned in challan. The bidder with pending or failure payment status shall not be able to submit their bids.

2-Additional Performance Security:-

Additional performance Security (APS) shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender. In such an event, the bidders who have quoted less bid price / rates than the estimated cost put to tender shall have to furnish Additional Performance Security in shape of **Term Deposit Receipt (TDR) Bank Guarantee** in any **Nationalized Scheduled Bank** pledged in favour of **Block Development Officer, Panchayat Samiti, Basta, Balasore** as per **Works Deptt. Office Memorandum No. 4559 dt. 05.04.2021** & subsequent **Office Memorandum No. 5992 dt. 27.04.2021**.

Only the successful bidder is required to furnish the required APS before the drawal of Agreement within 7 (seven) days of issue of LoA (also by e-mail) failing which the tender shall be cancelled with the forfeiture of EMD & action as deem proper will be taken as per rule including proceeding for blacklisting shall be initiated against the bidder.

Additional performance Security (APS) as per Notification No. 07556900052021-4559/W dt. 05.04.2021 of Works Deptt. Govt. Of Odisha APS shall be obtained only from lowest accepted bidder when the bid amount is less than the estimated cost put to tender as follows.

4-The scanned copy of bid security declaration, Registration certificate, GST, PAN, EPF or undertaking for EPF & affidavit including all required papers uploaded through website should be produced in original to the BDO, BASTA for verification within 7 days of opening of bid, otherwise the tender will be rejected.
