As per auction sale Committee Meeting held on 05.05.2023 regarding auction sale of damaged /broken unused iron items which are kept in Collectorate and Special Circuit House, Balasore to be auctioned on **dt.21.9.2023** and invite sealed quotation in plain paper by the undersigned to dispose-of the above items. The committee has fixed the minimum rate of the damaged/broken iron items as **Rs.26/-** per kg and the highest rate quoted will be selected as a successful quotation.

**Terms & Conditions:-**

1. The interested intending quotationers may submit their quotation in sealed cover with their full address so as to reach at District Nizarat Officer, Collectorate, Balasore by post or by hand on or before **dt.21.9.23** by **12 Noon**. The sealed Quotation will be opened by the undersigned on the same day at **4 P.M.** in the office chamber of the undersigned in the presence of quotationers or their authorised representatives.
2. Each Quotationer is required to deposit earnest money of **Rs.5000/-** (Rupees five thousand) only in shape of Bank Draft/Demand Draft in favour of Establishment Officer, Collectorate, Balasore payable at SBI Main Branch, Balasore. The Quotation paper without EMD will be summarily rejected. The EMD of unsuccessful Bidders will be refunded on the day of finalization of quotation.
3. The successful quotationer shall have to deposit **25%** of the Bid amount on the spot immediately after announcement and rest amount shall be deposited within **7 (Seven)** days from the date of auction, failing which the aforesaid deposit of earnest money will be forfeited and **2<sup>nd</sup>** highest bidder will be availed such chance as per terms and conditions.

5. On failure of lifting the auction items after full payment necessary ground rent @ 1% of the quotation money shall be charged per day till the removal from the godown.
