



- Bidding is open to all eligible bidders as defined under Odisha Contractors Registration Act of Works Department from time to time. Bidder registered as per eligibility criteria of class to each works in Annexure to Bid Notice column-6 under the Government of Odisha/ Other State Government/ Government of India/ State or Central Government Undertakings is also eligible to bid. The registered bidder outside the state can also participate in this online tender process after necessary portal enrollment, but shall have to subsequently undergo registration with appropriate authority within one month from acceptance of tender. Interested bidders may obtain clarifications regarding the minimum qualification criteria from the office of the Superintending Engineer, M.I.Division, Balasore prior to participation in the bid on or before 19.10.2023 up to 5.00 PM.
- Bidding documents can only be available on-line in the Government of Odisha website <http://www.Odisha.gov.in> & <http://tendersodisha.gov.in> from 20.10.2023 10.00 A.M to 03.11.2023 up to 5.00 PM for preview, download & submission.
- The Bidders desiring to participate in "On-line" bidding must possess compatible Digital Signature Certificate of Class-II or Class-III. The web site for the on-line bidding is <http://tendersodisha.gov.in>.
- Bids must be accompanied by a non-refundable fee as indicated at Column-5 of Annexure towards cost of bid documents for each work has to be transferred online through a process as mentioned in the Bid Documents. Bidder who has participated in online tender must have to deposit the bid cost. Non-submission of bid cost shall debar the bidder from participating in the on-line bidding system and informed to the authorities for cancellation of his contractor registration and also portal registration.
- The tender must be accompanied with EMD of the amount as in Column-4 (1% of the estimated cost) to be deposited online through a process as mentioned in the Bid Documents, failing which the bid will be rejected.
- Engineering (Degree/Diploma) contractors desirous of exemption of EMD should furnish the affidavit in this regard that they have not availed exemption for more than the prescribed limit along with the tenders as well as to submit original license at the execution of agreement for verification and necessary entry. Adjustment of EMD,

deposited for other works in this Division will not be entertained for the above work. All other terms and conditions can be had from the office of the undersigned during office hours.

7. Engineer contractors who want to avail EMD exemption have to submit one affidavit with tender declaring therein to the effect that they have not yet availed EMD exemption more than the prescribed limit during current financial year and to show the original Registration Certificate to the tender opening authority for confirmation at time of execution of Agreement.
8. The Bid documents should be up-loaded by the Bidders on-line in www.tendersorissa.gov.in accompanying the clear scanned copies of Valid Registration certificate, Valid GST, PAN card, No relation certificate and affidavit about the authenticity of the tender documents and Affidavit to avail price preference/ Exemption of EMD in case of Engineering /SC/ ST/ Contractors/Physically Handicapped contractor. The SC/ST contractors having Degree/Diploma in Engineering are not allowed to avail both the benefits.
9. Engineer contractors, /SC/ST/Contractor and Physically handicapped contractor who want to avail EMD exemption/Price preference have to produce original affidavit/No relation certificate at the time of execution of Agreement and to show the original Registration Certificate, GST registration certificate, PAN card to the tender opening authority for confirmation at the time of execution of Agreement for verification.
10. The Technical bid (Cover-I) generally consists of GSTIN, PAN, Registration Certificate, No relation certificate, Affidavits, Bid Security and any other information desired by officer inviting Tender.
11. Tender shall be uploaded separately for Technical Bids (Cover-I) & Financial bid (Cover-II) etc in standard formats prescribed in the bid documents displayed at Govt. of Odisha e-market place web site & submitted duly filled up if tender amount above 50 (Fifty) Lakh.
12. Technical Bids shall be received only "On-line" on or before 5.00 PM of 03.11.2023.
13. The Technical Bids received "on-line" will be opened in the office of the Superintending Engineer, M.I.Division, Balasore at 11.00 AM on dt: 04.11.2023 in presence of the bidders/Authorized agents who wish to attend. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and same venue.
14. The Financial Bids will be opened "on-line" in the office of the Superintending Engineer, M.I Division, Balasore at 11.00 AM on dt: 15.11.2023 in presence of the bidders/Authorized agents who wish to attend. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and same venue. No further correspondence in hard copy regarding Financial Bid opening.
15. It is mandatory that the Bid should be accompanied with the scanned copies of the valid Registration Certificate, No Relation Certificate, valid GSTN, PAN Card, with residential proof for official correspondence, Valid Mobile No. email Id and other requisite documents as per the Bid Document without which the Bid will be considered as non-responsive.
16. The bidders must have to furnish their valid email I.D for future correspondence and it is mandatory.
17. The affidavit to be submitted in legal stamp paper individually for each work by bidder.
18. The Successful bidder will furnish Bank contact details (Bank Address & e-mail ID) along



- with APS to verify the authentication of TDR/STDR.
19. The Lottery for the Bids, where in all eligible bidders have quoted 14.99% less than the estimated cost put to tender, will be conducted on dt. 18.11.2023 at 11.30 A.M in the office of the Superintending Engineer, M.I Division, Balasore. If the office happens to be closed on the scheduled date of lottery, then the lottery shall be conducted on the next working day at the same time and venue. No further correspondence in hard copy regarding lottery.
 20. The successful bidder has to submit the all Original affidavit/No relation certificate at the time of execution of Agreement.
 21. One bidder can submit only one tender paper to each of the works for which tender invited in this notice in his own DSC. Submission of more than one tender paper for any particular of work by a bidder through different DSC or through his own DSC for a particular tender will be liable for rejection of all such tenders.
 22. The authority will not be held responsible for any technical snag or network failure during on-line bidding.
 23. The bidder must go through the Bid Documents meticulously before up-loading the tender to the web-site.
 24. Any Corrigendum/ Addendum/ Modifications/ Additions will be displayed in the website **www.tendersodisha.gov.in**
 25. Fixed deposit holders / Exemption holders by order of Central / State Govt. will also be required to furnish the requisite security amount along with the bid in the prescribed form, otherwise the bid shall be considered as non-responsive. Engineering Contractors willing to avail exemption of EMD shall furnish an affidavit to the effect that he has not availed the benefit during the financial year and original licence shall be submitted before the authority for making necessary entry in the original licence, if successful & selected for awarding the work as per Letter No FA-Codes-6/2011- 600 dated 18.1.2011 of Works Department. Non response to deposit of **Additional** Performance Security will invite forfeiture of E.M.D blocking of D.S.C. and licence issuing authority will be moved for cancellation of contracting licence.
 26. Additional Performance Security (APS) is being obtained from the Successful Bidder when the Bid amount is less than the estimated cost put to tender to the extent of exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount in shape of N.S.C/Postal Saving Bank Pass Book/K.V.P/ Post Office Term deposit receipt / Deposit receipt of any Nationalized /Schedule Bank duly pledged in favour of the Superintending Engineer, M.I. Division, Balasore within seven days of issue of Letter of Acceptance (LoA) by the Divisional Officer (by registered post/ e-Mail address/ whatsapp message) otherwise the bid of the successful bidder shall be cancelled and the Earnest Money Deposit/ Bid Security shall be forfeited. Further proceeding for blacklisting shall be initiated against bidder.

27. The applicable Additional performance security (APS) in shape of Term Deposit Receipt pledged in favour of Divisional Officer/ Bank Guarantee in favour of Divisional Officer from any Nationalized/Scheduled Bank in India counter guaranteed by its local branch at Bhubaneswar within seven days of issue of Letter of Acceptance (LoA) by the Divisional Officer (by e-mail) to the successful bidder otherwise the bid of the successful bidder shall be cancelled and the Earnest Money Deposit/ Bid Security shall be forfeited. Further proceeding for blacklisting shall be initiated against the bidder' in pursuance to Works Department Office Memorandum No 14459 dated 20.09.2018
28. The amount quoted by bidders shall remain valid for 90 (ninety) days from the date of opening of financial bid. If any bidder backs out from the bidding process, or make any request for alteration or modification in terms & condition of the bid shall debar the bidder from participating in the online bidding system and his portal registration shall be blocked including recommendation to registering authority for cancellation of his registration as contractor including forfeiture of bid security deposited.
29. Quality control tests as per specification for all items of the work executed will be taken in nearly Govt. Quality Control Laboratories of Minor / Medium / Major Irrigation Organization. It is binding on successful bidder to extend all necessary support in getting the tests done till completion of the work in all respect.
30. No Engineer of Gazetted rank or other Gazetted officer employed in Engineering or Administrative Department of the State Government is allowed to work as a contractor for a period of two years after his retirement from Government service without due permission of the Government.
31. The bidder shall have to furnish No relation certificate along with the tender to the effect that no officer of the Department to the rank of Assistant Engineer or above is related to him.
32. The work which is meant for the current financial year has to be completed within the current financial year, as the allotment for same will lapse during the current financial year, afterwards no claim for payment of the work bill will be entertained.
33. A General guideline on Extension of time has been issued vide Ir no 20415 dated 14.09.2015 of the FA-cum-Joint Secretary to Govt. DOWR, Govt. of Odisha for information of Contractors for preparing the work programme, planning and schedule.
34. GST (Goods and Services tax) as applicable will be deducted from gross amount of the bills
35. Conditional tender will summarily be rejected.
36. Agreement shall be drawn only after due verification of EMD & APS of the successful bidder. If any fake instruments are detected, Criminal proceedings will be initiated against the defaulting bidder and action will be initiated for blacklisting through the license issuing Authority.
37. Before acceptance of tender, the successful bidder will submit a work programme and milestone basing on the financial achievement so as to complete the work within the stipulated time and incase failure on the part of the agency to achieve the milestone, liquidated damage will be imposed.
38. The bidder must provide the mobile No. having whatsapp facility, address with PIN No. and e-mail ID along with the tender documents for any intimation regarding tender.
39. All the existing provisions of OPWD code with amendment from time to time will be applicable in deciding the tender. All correspondence regarding the tender process will be

communicated by registered post/ e-mail address/ whatsapp message. All are requested to check the e-mail/ whatsapp message from time to time regarding the tender. No claim whatsoever will be entertained for non receipt of communication in hard copy.

40. Electronic receipt of cost of tender paper has been successfully tested through SBI payment gateway. Now it has been decided to introduce electronic receipt of Cost of Tender Paper and Earnest Money Deposit on submission of bids through payment gateway of designated banks such as SBI/ICICI Bank/HDFC Bank for all Government Departments, State PSUs. Statutory Corporations, Autonomous Bodies and Local Bodies etc. in phases (ANNEXURE-I). The process outline as well as accounting and reporting structure are indicated below :
- a) It will be carried out through a single banking transaction by the bidder for multiple payments like Cost of Tender Paper and Earnest Money Deposit on submission of bids.
 - b) Various payment modes like Internet banking/ NEFT/RTGS of Designated Banks and their Aggregator Banks as well can be accessed by the intending bidders.
 - c) Reporting and accounting of the e-receipts will be made from a single source
41. The tenders will be processed / considered as per office memorandum issued by the works department Govt. of Odisha vide No 12366 dated 08.11.2013.
42. Other details can be seen from the bidding document.
43. All existing clauses and terms & conditions issued from time to time by the department are applicable and mandatory for finalization of the tender.
