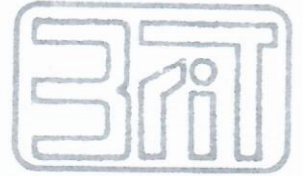

Balasore Regional Improvement Trust, Balasore invites Sealed quotations from the Authorized Stockiests/Distributors/Dealers of the local market like **Bajaj/Crompton/ Panasonic** etc., having special authorization letter from the Company for supply, installation & commissioning of all-in-one Solar Street Lights, LED Street Lights, Poles and accessories etc., complete fitting as per the specifications available in the Quotation Paper. The dealer must enclose a copy of Authorization letter from Company with the quotation paper as per specification details enclosed for Genuineness Guarantee of the lighting systems. The bidder should have Registered Office at Balasore. Single OEM, Single Bid shall be preferred. Besides, the rate of latest energy efficient luminaries having advanced technology, commonly accepted standards for street lighting and having improved operational and maintenance facilities may also be provided against each company in separate sheet. The cost of Quotation is Rs.3,000/- + GST 18% extra as applicable (Non-refundable). The Quotationer shall have to deposit the Earnest Money Deposit of Rs.50,000/- (Rupees Fifty Thousand) only in shape of Bank Draft/Banker Cheque favouring to the Chairman, B.R.I.T. Balasore payable at Balasore, which will bear no interest during the period of deposit with B.R.I.T. & shall refund back to the successful bidder after completion of 1(One) year from the date of acceptance of quotation paper. Guarantee for at least 5(five) years on Solar/LED lightings are required. Defect lights should be replaced/repared within 48 hours. The Quotationer/Tenderer should have to submit audited Balance Sheet for last 3 years to be enclosed with the Company minimum average annual Turnover/Returns for at least 200 crores in Solar business in last 3 years in India. The GST Clearance Certificate should be enclosed with the quotation paper. The lowest rate quoted by the quotationer shall be valid for a period of one year from the date of finalization of tender. The unsuccessful tender/quotation EMD amount shall be refund back within a period of 60 days. Enclose Technical Bid and Price Bid separately.
