In continuation to this office Advt. No. 4821 Dt. 16.10.2023, Applications are hereby invited from the interested retired JEs and AEs for their re-engagement as OSD (Officers on Special Duty) in PR & DW Deptt. across this district for a period of one year / till joining of regular JEs or until further orders.

1. Eligibility Conditions :-

- (i) The JEs/ AEs to be designated as OSD who have retired from Government Service on attaining the age of superannuation and below the age of sixty five years having good service records and are physically fit shall be eligible to be considered for re-engagement.
- (ii) JEs/AEs against whom departmental proceedings or criminal cases are contemplated / pending or who have been penalized for misconduct during the period of preceding five years will not be eligible for consideration.

2. Selection Process :-

- (i) Selection of persons will be made through open advertisement as above.
- (ii) There shall be a Selection Committee comprising of Technical experts to be decided by the appointing authority for the posts required to be filled up by re-employment.

3. Tenure, Terms and Conditions :-

- (i) The re-employment shall be made for a period one year not beyond the age of sixty-five of age or till the posts are filled up by regular JEs/ AEs whichever is earlier.
- (ii) The consolidated monthly remuneration shall be fixed to 20,000/- P.M. with addl. Amount not exceeding 5,000/- P.M. towards conveyance allowance / mobile allowance etc.
- (iii) Re-employed OSD shall be governed by the provisions of Odisha Government Servants' Conduct Rules, 1957 and shall be liable to be proceeded against for their misconduct, omissions and commissions as per the provisions under the Odisha Pension Rules, 1992.
- (iv) The re-employment can be terminated at any time by the respective appointing authority due to unsatisfactory performance of any of the re-employed OSD by giving one month notice. On the contrary if any re-employed OSD desires to resign he shall do so by giving one month's written notice to the competent authority.
- (v) Total 45 numbers of retired JEs / AEs (Civil) will be selected through walk-in-interview process.
- (vi) The interested retired JEs / AEs (civil) may apply to the CDO-cum-EO, Zilla Parishad, Balasore in plain paper giving details of their Bio data and service period particulars as noted below by registered post only addressed to "The CDO-cum-EO, Zilla Parishad, Balasore, Vivekananda Marga, Pin-756001" to be reached on or before 15/12/2023 by 5.00 PM positively, as per the application placed at Annexure -I.
- (vii) Date of walk- in -interview, time & venue will be intimated to the applicant in due course of time.
