

QUOTATION/TENDER CALL NOTICE FOR HIRE OF VEHICLE

beaten quotations/tenders are invited from Interested Travel Agencies/Tour Operators or private individuals for providing No.1(One)of (Bolero/TUV 300, Sumo Gold) ,Any car Diesel 7 seated driven vehicles, which shall conform to the terms and conditions (Annexure-II) for official use in ICDS Project Basta on monthly / daily basis .

1. The vehicle must be in Road Worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid **Registration Certificate, Insurance Certificate, Fitness Certificate, Valid Contract Carriage Permit, proof of up to date Tax payment** etc. which are **mandatory** for playing of vehicle.
2. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passengers vehicle.
3. The Driver should be well behaved, gentle and obedient in nature.
4. A sum of RS. 1000/ shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of CHILD DEVELOPMENT PROJECT OFFICER,BASTA, and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
5. The monthly rate of hire charge be quoted separately in the general bid information (excluding fuel and lubricants).
6. The vehicle must achieve a fuel efficiency of 12 KMs per Litre.
7. The details of the make and year of manufacture of the vehicle, registration nag mileage(KMs covered per Litre) and name of the Driver with Driving License Number and period of validity should be specifically provided in the general bid information to be furnished with Quotation/Tender(Annexure-III)
8. The Quotation completed in all respect should reach the undersigned on or before 22/06/2024 at 05 PM and shall be opened on 26/06/2024 at 10.00 AM in presence of the bidders or their authorized representatives at Sub-Collector's Office,Balasore. The sealed cover should be super scribed in Block Letters as "QUOTATION FOR ENGAGEMENT OF HIRED VEHICLE -OR USE IN THE ICDS PROJECT BASTA.



TERMS & CONDITIONS FOR HIRING OF VEHICLES

The following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on monthly rent basis:

The hired vehicles, during period of contract, shall have all necessary MV documents such as valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up to date Tax payments etc. and DL of the driver available all the times. The Department/Office hiring the vehicle shall not be responsible for any damage/loss caused to hired vehicle or loss of life/injury made to any person or damages to any property on account of use of hired vehicle any manner whatsoever. The hire shall be responsible for all such litigation.

The hire charges to be paid after deduction of Income Tax or any other tax as applicable by law for monthly basis is final but does not include cost of Diesel, which is to be paid separately bearing on actual consumption and lubricants as per existing Government norms. All the expenditure of the vehicle towards repair, replacement of spare parts, Lubricating Oil of engine, Gear Box & differential coolant, Tires & Tubes, Battery etc. will be borne by the bidder.

It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the owner.

The vehicles shall report for duty for minimum of 25 days in a month.

The vehicle shall not be more than 3 years old from the initial registration and also in good running condition during the period of contract.

In case of breakdown for reason whatsoever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle bidder.

In case of the vehicle do not report regularly, the authority will be at liberty to reject the agreement and may engage vehicle from other source.

In case of emergency, the driver will have to report for duty as per the requirement of hirer. No extra payment shall be demanded.

Monthly hire charges of selected bidder will be paid in every succeeding month, as far as possible within fifteen days of the submission of bills by the service provider and no advance payment will be made.

If the services are found to be unsatisfactory, the client shall give one month notice and terminate the agreement.

In case of the service provider intends to withdraw the service of his vehicle and terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal of service and termination of agreement.

If the bidder violates any of the terms of contract, Government shall forfeit the entire amount of security deposit.

All any of the tenders (or bids) submitted can be rejected without assigning any reasons thereof. No claims whatsoever, shall be admissible for the alleged loss/damage suffered by the bidders on account of such rejection.

The application form must be signed by the vehicle owner or bidder & properly sealed & also attach all relevant documents including drafts as per the terms & condition.

The authority will not be responsible for any minor or major repair of the vehicle.

The owner of the vehicle should not be reluctant to send the vehicle to rural area as of this Project
