Sealed quotations / tenders are invited from interested reputed Travel Agencies / Tour Operators or Private individuals having valid GST registration for providing 1 ( One) number of AC BS-6 compliant Diesel driven vehicle (Commercial ) which shall conform to the having sitting capacity not more than ten including Driver, which shall conform to the terms and conditions ( Annexure-II ) for official use in ICDS Project, Khaira on monthly rent basis.

1. The Vehicle must be in Road Worthy condition, **shall not be more than 3 years old** from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness certificate, valid contract carriage permit, proof of up to date Tax Payment etc. which are mandatory for plying of vehicle. The vehicle with latest date of registration & latest running kilometres shall be given preference.
2. The office shall not be responsible for any damage /loss caused to hired vehicle or loss of life/injury made to any person or damage to any property on account of use of hired vehicle any manner what so ever. The hirer shall be responsible for all such litigation.
3. The hire charges to be paid for monthly basis is final but does not include cost of diesel. Which is to be paid separately basing on actual consumption and lubricants as per existing Governments norms. All the expenditure of the vehicle towards repair, replacement of spare parts, lubricating oil of Engine, Gear Box & differential Collant, Tyres & Tubes, Battery etc. Will be borned by the bidder.

7. In case of breakdown for reasons what so ever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle / bidder.
8. In case of the vehicle do not report regularly, the authority will be at liberty to reject the agreement and may engage vehicle from other source.
9. In view of the emergency nature of work the vehicle along with the driver needs to be at the disposal of the office for 24 hours all along the week.
10. In case of emergency, the driver will have to report for duty as per the requirement of hirer. No extra payment shall be demanded.
11. Monthly hire charges and reimbursements towards cost of diesel ( as per actual) and lubricants ( as per Govt. Norms) of selected bidder will be paid in every succeeding month, as per as possible within fifteen days of the submission of bills by the service provider and no advance payment will be made.

12. In case the service provider intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal of service and termination of agreement.
13. A sum of Rs. 5000/- shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the C.D.P.O, Khaira and submitted along with the tender as security deposit . After completion of tender process, the amount will be refunded to unsuccessful bidders.
14. The details of the make and year of manufacture of the vehicle registration No. , Mileage ( KMs covered per litre) and name of the Driver with Driving License No. and period of validity should be specifically provided in the general bid information to be furnished with the Quotation/Tender ( Annexure-III)
15. G.S.T. registration is mandatory for the Bidder.
16. The Tender papers completed in all respect should reach the undersigned on or before 03.08.2024 by 4.00 PM. and shall be opened on the date 05.08.2024 at 11.00 A.M. in the office of the BDO, Khaira in presence of the bidders or their authorized representatives.
17. If the bidder violates any of the terms of the contract, Government shall forfeit the entire amount of security deposit.
18. The present hiring Vehicles has been allowed only for the period mentioned i.e. for the FY 2024-25.
19. The vehicle shall not be more than 4 years old from the initial registration and also in good running condition during the period of contract.
