




TERMS & CONDITIONS

1. The vehicle must be in good quality and should satisfy the quality check on performance when required.
2. The vehicle should be of reputed brands
3. The bidder should have valid GST.
4. The vehicle must have at least the minimum specification given herewith.
5. The bidder should have Pan Card with up to date Income Tax Returns.
6. The bidder should have ISO 9001: 2015 certificate.
7. The bidder should have GMP certificate
8. The bidder should have trade mark certificate.
9. The bidder should have MSME certificate.
10. The bidder must provide an undertaking for not being black listed.
11. The bidder must give an undertaking for supply, installation, testing & commissioning of the items immediately.
12. The bidder should give an under taking to always be in readiness in case of any repair and maintenance whenever required and to comply the same within 24 hours.
13. The Price/rate quoted by the bidder shall remain unchanged during the entire period of the contract and shall not be subject to variation of any amount.
14. The Block development Officer, Bahanaga reserves the right to accept/ reject any/ all tender without assigning any reason.
15. All the disputes arise in the above case will be preferred to the BDO, Bahanaga and this decision will be final.
16. The rates should be quoted at bidder's risk inclusive of all MV taxes, duties, all type insurance, service tax, etc.(to pay all taxes and duties bidder's responsibilities).
17. All documents to be submitted by the firms should be self -attested. No document will be entertained unless attested.
18. The Earnest Money of the bidder will be forfeited, if they withdraw their offer/ rates or modify the terms & conditions of the same during the validity of their offer which are adverse to the business ethics.
19. Conditional EOI will not be accepted in any circumstances.
20. It will be at the discretion of the Block Development Officer, Bahanaga to make any inquiry in order to judge the ability and capacity of any firm and the decision of the **Block Development Officer, Bahanaga** in this regard will be final.
21. In case the Tenderer, whose rates have been approved, and after the order is placed fails to discharge the obligation of tender so awarded to him, part or in full or on the grounds of quality of staff **Block Development Officer, Bahanaga** has the right to place the order to other firm at the risk and cost of tenderer and the **Block Development Officer, Bahanaga** shall have the right to forfeit the EMD or to take any legal action against defaulter agency/firm.



22. No interest on Earnest money will be paid by the PS Bahanaga Authority.
23. The Earnest Money of unsuccessful Bidder will be returned on finalization of the bids.
24. The Earnest Money of the successful Bidder along with security deposit will be retained and treated as security deposit up to expiry of warranty period without interest.
25. Any offer which bears cutting, over -writing in the rates shall not be considered.
26. Income Tax to be deducted at source in all cases of payment to the executants.
27. These terms and conditions are to be signed by the bidders at the place specified below which would be finally and legally binding on him. The bidder is not entitled to insert / add / delete any term / condition whether made herein or thereby in separate note / letter and the Executive Officer, Balasore Municipality shall not be bound for any such addition / deletion.
28. The Executive Officer, Balasore Municipality shall also have the right to bifurcate and award the contract to any number of bidders and decision of the Executive Officer, Balasore Municipality in this regard shall be final and binding upon the bidders.
29. If the Executive Officer, Balasore Municipality is not satisfied with the services provided by the firm it may either receive the contractor imposed appropriate cut in the payment as the case may be. Decision of the Executive Officer, Balasore Municipality shall be final in this regard.
30. The BOVs will function within all the location in Balasore Municipality. It will be also engaged for the sweeping purpose at multiple times in Balasore Municipality areas as and when suggested by the undersign.
31. The machine should not remain in break down condition and should never run out of fuel during the working hours; if it is found to be doing so then Balasore Municipality will neither be responsible nor payable for the same.
32. The number of BOVs that to be procured will be decided after selection of the L1.
33. Payment Conditions are as mentioned below.
 - i) The Officer has to deposit Rs. 10000/- as an earnest money in shape of B.C/B.D along with their Offer, EMD to be submitted in the name of **Block Development Officer, Bahanaga, Balasore** payable at Bahanaga.
 - ii) Payment should be done after submission of final detailed Report both in hard and soft copy along with all surveyed dorms / surveyed data and all reports in the manner & format as prescribed.
 - iii) The successful bidder shall deposit a **Security Deposit of 25,000/- or 5% of the total cost**, whichever is higher.
