Sir,

It has been brought to the notice of the undersigned that, Tender Call Notice no OAVKTB/2024/7 Dated 26.09.2024 has been floated by of your good office for procurement of **Steel Shelving Cabinet (Almirah) & Office table.**

In this connection it may be stated here that Director, Export Promotion and Marketing, Odisha, Bhubaneswar has concluded Rate Contract for the store item Composite Office Table conforming to I.S. No. 8126/1993 & Steel Shelving Cabinet (Almirah) and the rate contract for these two items is valid upto dt 30.08.2025 & 10.03.2025 respectively. The rate contract circulars containing specifications, rates, rate contract holders are available in the DEPM website [www.depmodisha.nic.in](http://www.depmodisha.nic.in).

According to the Govt of Odisha purchase policy and provision made in Appendix-6 of the OGFR Volume II, reiterated vide Finance Department Office Memorandum No 4939/F dt 13.12.2012 clause 5 envisage that procurement through rate contract system, in respect of goods for which rate contract has been entered into by the Director of Export Promotion and Marketing, purchase of such goods by all the Departments of Government, Quasi Govt Agencies and state owned Corporations should be only from sources with whom such rate contract have been entered into by placing order in accordance with the procedure outlined for the purpose by the Industries /MSME Department. The finance Department Office Memorandum No 27928 dtd 16.10.2020 may also be referred in this regard.

As per the Rules of Rate Contract with the Micro and Small Enterprisers of the State - 2014 clause 3(l) : "Items /services means the goods /services manufactured /provided by MSEs which contractor has agreed to supply/service under the Rate Contract can not be tendered by the State Govt. Departments /Agencies under the control of the State Govt. In

case any Govt. Department/ Agencies invites tender for the rate contract items /services the DEPM shall have the power to cancel such tenders.”

In view of the above fact , you are requested to follow the procedure and procure said items from the MSEs having valid Rate contract with DEPM at the Rate Contract Price without inviting tender.

Action taken in this regard may be intimated to the undersigned.
