The Sub-Collector, Nilgiri-cum-Chairman, Regulated Market committee, Nilgiri invites rate quoted bid in sealed cover from reputed manufacturers/ authorized registered dealers for supply and installation of 07 (Seven) Nos of Street Light with Pole in Ajodhya Market Yard & LED Street Light for PPCs.
2. The Specification Light is of 8 Mtrs. Hot Dip Galvanized Octagonal Pole, Top Dia 70mm, Bottom:130, Thick: 3MM, Base Plate200×200×16 4Nos of M 20×600 mm foundation Bolt including Foundation made with Cement, Rod, Chips, Sand etc. 4 way Bracket with 4 Nos of 120 W LED Street Light, 25 Mtrs. 4.0 Sq. MM. Service wire with Stay wire, 1 No of 32 AMP DP on-off switch with Board, Marble Stone Works including Erection of Pole & Installation of Luminaries with Transportation Charges. The LED Street Light must be of reputed company i.e. Bajaj, Havells, Crompton, Panasonic etc. make.
3. LED Street Light 50W, 6K with IP66 must be of reputed company i.e. Bajaj, Havells, Crompton, Panasonic etc. make.
4. The Bidder should be an Original Manufacturer/ Authorized Dealer of the Equipment/ item as stated above and capable of providing adequate and timely after sales service. Necessary proof/ documents towards Bidder being Manufacturer or its Authorized Dealer must be submitted along with the Bid.
5. The Bidder should have successfully supplied such products to any other Organization/ Institution/Govt. Office in Odisha or in any state/institution/ organization (Experience Certificate should be attached).
6. The Bidder should submit attested photocopies of Valid Manufacturer /Dealership, Registration Certificate, GSTIN, GST Clearance certificate and PAN Card as well as Authorization Certificate (In Case of not an Original Manufacturer) etc. along with the Bid.
7. The Bid Document must be enclosed with **an EMD amounting of Rs. 15,000/- (Rupee Fifteen Thousand) only (Refundable)** in shape of Demand Draft drawn in any Nationalized Bank payable at Nilgiri in favour of the Secretary, Regulated Market Committee, Nilgiri. The **Paper Cost is Rs. 600/-(Rupees Six hundred) only(Non-Refundable)**.
8. The Bidder must submit two envelopes for Technical Bid and Financial Bid separately.
9. The Bidder should enclose detailed write-up along with necessary technical specification/document/drawings & design for all the makes and models in the Bid.

The Bidders/Tenderers having ISO Certification with at least 05 (Five) Years of Experience of both Sales and Service, having own authorized Service Centre in Odisha to extend service support for 24×7 and when required or priority basis (most probably within 24 Hours after complain booked), shall be given preference over other(s) for which the Bidders may submit documentary evidence/ proofs in favour of their claim along with the Bid.

12. All price quoted should be inclusive of all taxed and delivered at Ajodhya Market Yard of Regulated Market Committee, Nilgiri, erecting of Pole & Installation of Luminaries.
13. All equipment must cover at least 02(One) year warranty.
14. The Bidder should quote the AMC rate for each item for three consecutive Years after successful completion of warranty period.
15. The successful Bidder must supply the equipments within 07(Seven) days of issuance of the Supply Order failing which the supply order may be cancelled.
16. The Bidders should depute their representative for demonstration of different equipments on **Dt. 12.12.2024 at Office of the Regulated Market Committee, Nilgiri**
