No.351/BRIT, Balasore- In exercise of the powers conferred under Sub-Section(1) of Section-32 of the Odisha Town Planning & Improvement Trust Act, 1956 (Odisha Act, 10 of 1957), the Balasore Regional Improvement Trust, Balasore, do hereby notify for information of the General Public of Balasore that the GIS/RS based Master Plan for the Master Plan Area, Balasore comprising 205(two hundred five)nos. of Revenue villages i.e. existing 109nos. & newly included 96nos. of Revenue Villages as specified in the Schedule given below over an extended area of Ac.233.82 Sq.Km., which the aforesaid Act has already been enforced by the Govt., in H & U.D.Department vide S.R.O.Notification No.866/74, dtd.19.11.1974, No.30978/HUD, dtd.15.09.1995, No.22334/ HUD, dtd.21.09.16. The draft of which was published under Section-31 (1) of the Odisha Town Planning and Improvement Trust Act' 1956 inviting objections and suggestions vide this Office Notification No.5355/BRIT, dtd.15.11.2018 (Published in the Odisha Gazettee on 28th January 2019) has now been approved under Section-32 of the OTP & IT Act, 1956 by the H & U.D.Department, Govt., of Odisha vide Letter No.27952/HUD, Dtd.26.12.2024 in due consideration of the objections and suggestions received from the public within the stipulated period of sixty days.




The approval of Master Plan is available in the Office of Balasore Regional Improvement Trust, Balasore At-Block-A, O.T.Road Shopping Complex, Station Square, Balasore for perusal of person interested in the said plan during Office hours on any working days with effect from the date of notification in the Odisha Gazette.

Hereinafter, from the date of publication of this notification no person, Private/Public Institution/Industry, Department of Government/Semi-Government owner of any land shall erect or proceed with construction of any building or structure or work or enter into or carry out a contract in respect of any land within the area included in the Master Plan unless he/she has applied for and obtained permission from the Secretary, Balasore Regional Improvement Trust, Balasore, as required under Sub-Section(3) of Section-31 of the Odisha Town Planning and Improvement Trust Act, 1956 to the effect that, the proposed building or work or contract is in accordance with and not in contrary to any of the provisions of the Master Plan.

It shall be the duty of the owners of land to ensure that development on their land is not in contrary to this Master Plan. Further, hereinafter all sub-divisional lay-out plan intended for parceling out, or selling in smaller plot with adequate provision of roads and open spaces shall also require prior approval of B.R.I.T. Balasore.

Any development which shall be made in any land without permission of B.R.I.T. Balasore and which is contrary to the provisions of Master Plan shall not be taken into account in awarding compensation in even of land being acquired. Subsequently under provision of O.T.P. & I.T. Act, 1956 for implementation of any Development Scheme. Taking up construction without permission shall be punishable under provisions of the said Act.




