Departments as per office Memorandum No. 0755690001201: -6785, dt.09.05.2017 & Ltr. No. 07679600032U1.5-1-2-06.12.2017 of Works Department. A standard form is attached, 1DTCN. The bidder should remit the cost of Tender Paper through NEFT / RTGS payments using internet payment of the bank in which the bidders holds his account by adding the account no. as mentioned in the challan. The bidders with pending or failure payment status shall not be able to submit their bids.

Additional Performance
Security

The successful bidder who has quoted less bid price / rates less than the estimated cost put to tender shall have to furnish Additional Performance Security as stated below in shape of **Term deposit receipt/NSC/Bank Guarantee** duly pledged in favour of Nilgiri, Balasore within 7 days from the date of intimation. The bid shall be cancelled with forfeiture of EMD. If the successful bidder fails to deposit the Additional performance security deposit **within 7 days from acceptance** of his/her bid, he/she may be blacklisted as per works dept. letter No.13286 dtd.07.09.2017.
