

- 1) The Contractor should possess valid Contract licence, I.T.C.C. & PAN No./GST Registration/GST Clearance on the prescribed form.
- 2) The tender is open to contractors & individual firms only. Application from joint venture is not acceptable. The tender documents will be made available to purchase in the Office of B.R.I.T. Balasore from 13.08.25 to 20.08.2025 within 11.00 A.M. to 1.30P.M.
- 3) The Earnest Money Deposit (EMD) as stipulated in the table shall be deposited in shape of Bankers Cheque/Demand Draft drawn from any Nationalized Bank in favour of Chairman, B.R.I.T. payable at Balasore.
- 4) The tenderers are required to quote their rates, item wise in both words & figures inclusive of all taxes, royalties etc., (if any) including labour cess. In case of less rates (below estimated cost) quoted by the tenderer, the differential amount is required to be deposited in shape of Bankers cheque favouring Chairman, B.R.I.T., Balasore at the time of Agreement.
- 5) Exemption of E.M.D. shall not be considered in any case. Tenders without EMD, incomplete tender papers, invalid Contract licence, I.T.C.C. or PAN card and GST Clearance Certificate shall not be considered. The tender documents duly filled in along with other valid documents & EMD shall be sealed in an envelope super scribed with the Sl. Number, Name of work applied for along with the date of opening.
- 6) The tenders are required to be dropped in the tender box at the Office of Secretary, B.R.I.T, Balasore on dt.22.08.2025 up to 1.00P.M. & the tender papers will be opened on the same day on 22.08.25 at 4.00P.M. in the Conference Hall of B.R.I.T. in presence of the bidders or their authorized representatives.
- 7) The tenderer has to sign in each page of the tender documents. Cutting/Over writing/Correction if any should be initialed by the tenderer. Serial Number of the works are to be mentioned in the top of the Tender Paper/Envelope to be dropped in the Tender Box.
- 8) An affidavit towards authentication of documents must be attached with the tender paper.
- 9) If the Office happens to be closed on the date of last sale/receipt/ opening of the tender/bids as specified above, the bids will be sold/received/opened on the next working day at the same time & venue.
