TECHNICAL BID should contain Self Attested copies of the following documents:

1. GST Registration Certificate.
2. PAN Card.
3. GST Return Copies(GSTR 3B) for Last 3 Months.
4. Latest IT Return Copies of the 2024-25 AY.
5. Address and contact details of firm/agency/supplier/company etc. (Local address of business place at Balasore with contact details).
6. The firm/agency/company/supplier etc. must have designated place of business and submit full local address and contact details.
7. Experience certificate or Supply Order with Invoice of the Uniforms supplied about supply of Uniforms to Govt/ Recognised Institutions.
8. An affidavit regarding the firm/agency/company etc. has not been blacklisted by any State Govt./ Central Govt. / Govt. undertaking organizations/Institutions.
9. Those who do not qualify in the technical bid their financial bid will not be opened.

FINANCIAL BID should contain the Price/ Rates of Complete Set of Uniform per student separately for Boys and Girls as mentioned above in prescribed format. All prices should be inclusive of taxes.

General Terms & Conditions :

1. The bidders should submit the Technical & Financial Bids in separate sealed envelopes mentioned in the top of the envelop as "Financial Bid" & "Technical Bid" and put the said two envelopes in one large sized envelope with superscription "**Tender for supply of Uniforms to the students of OAV, SUTEI, REMUNA, BALASORE**".
2. Sizes of the uniforms/Dresses may vary from student to student. The selected bidder shall have to measure the actual size of the Uniforms at School point. Due care needs to be taken for girl students with female Technician/Tailors.
3. No conditional bids shall be entertained and the same will be out rightly rejected at first instance.
4. Quality being the essential for procurement of the articles, the Principal of the respective OAV reserves right to select the items verifying the specification and brand of the articles.
5. The bidder with lowest evaluated financial bid (L1) would be considered for award of contract. In case, the lowest bidder (L1) is disqualified after physical verification of the items or any other reason then negotiation will be made with the second lowest (L2) bidder for award of the contract at (L1) price. However, the decision of the Vidyalaya Level Committee will be final for award of contract.
6. The price quoted by the bidders shall not in any case exceed the unit cost prescribed by OAVS inclusive of transportation cost and labour cost.
7. The items should be as per the specifications enclosed in the tender notice.
8. The Bidders have to produce the samples of the above mentioned items on the date of opening of Bids and finalisation of the Bidder.
9. The Authority reserves the right to reject all bids / terminate the entire tender process without assigning any reason thereof.
10. The bidders shall strictly follow the Colors and designs of Uniforms at par with the guidelines provided by Odisha Adarsha Vidyalaya Sangathan, Bhubaneswar.
11. The bidders shall have to affix the OAVS logo on each dress as per the requirement.
12. The house dresses must be Printed on their Back side with Name of School, Name of the House along with Motto of their respective houses.
