CALL FOR EXPRESSION OF INTEREST

The Sub-collector, Baleshwar-cum-Chairman, Regulated Market Committee(RMC), Jaleswar, Baleshwar invites Expression of Interest(EOI) from registered and experienced Architects/ Architectural Firms of Odisha for preparation of Plans & details Estimates including innovative concepts, layouts, drawings, maps and developmental ideas of various civil construction projects under the jurisdiction of RMC, Jaleswar.

Scope of Works:

The scope of works includes preparation of architectural plans and estimates of the projects i.e. development of daily/weekly RMC market, Jaleswar Municipality, development of proposed sub-Market yard at Bolang under Baliapal block, development of proposed Agri.-Market Complex at Dehurda, Bhogarai and any other market related developmental work to be entrusted by Authority. The scope includes detailed survey of the particular land, conceptual and innovative design, site planning and layout, detail drawings and maps, preliminary cost estimates and any other architectural inputs required for execution.

Eligibility Criteria:

The applicant must be a registered Architect with the Council of Architecture(COA). The Architect/Architectural Firms must have relevant experience in planning/design of markets, commercial building and similar infrastructure projects. Preference may be given to the Architects/Firms having experience in government or PSU projects.

- ii. Copy of the COA registration Certificate.
- iii. Profile of the Architects/Firms.
- iv. Details of Similar Work executed as experience (With Supporting documents).

- vi. PAN/TAN/GSTN Certificates.
- vii. Any Other Document(s) needed by Internal Evaluation Committee.

Last date of Submission of Expression of Interest: interested Architects/ Firms may submit their EOI along with required documents in sealed Cover or as prescribed by the office, addressed to The Secretary, regulated market Committee, Jaleswar, At-Nandika, Po-Jaleswar, Dist.-Baleshwar, Odisha and the EOI must be submitted though Speed Post/ by hand on or before Dt. 06/02/2026.
