

If the office happens to be closed for any administrative reason on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
03. The Authority will not be held responsible for any postal delay or other inconvenience during bidding process,
04. The authority reserves the right to cancel any or all bids without assigning any reason thereof.
05. Any Addendum/corrigendum will be hosted exclusively on the Websites mentioned supra and are requested to check it periodically during the bidding process.
