Sealed quotations/tenders are invited from interested reputed Travel Agencies/Tour Operators/Private individuals for providing 01(One) number of TUV300/Bolero/Ertiga AC Petrol/Diesel driven vehicles having sitting capacity not more than 10 (Ten) including driver, which shall confirm to the Terms and Conditions(Annexure-A) for official use in ICDS Project Bhograi-R on monthly rent basis . **The period of the contract shall be one year from the date of finalization of the tender process .**

1. The service provider shall have a valid OGST registration to participate in the tendering.
2. The vehicle must be in road worthy condition, shall not be more than 03(Three) years old from the date of initial registration and must have valid registration certificate, Insurance, fitness Certificate, Pollution Certificate, Valid contract carriage permit, proof of up to date tax payment etc. Mandatory for plying of vehicle.
3. The driver of the vehicle must have a valid driving license for driving light transport passenger vehicle and should be sufficiently experienced in driving transport/passenger vehicle.
4. The driver should be well behaved, gentle and obedient in nature.
5. A sum of **Rs.5000/- (Rupees Five Thousand)** shall be deposited by the intending bidders in shape of a Account payee bank draft drawn in favour of the **C.D.P.O. Bhograi-R** and submitted along with the tender as security deposit. After completion of tender process ,the amount will be refunded to unsuccessful bidders.
6. The maximum monthly rate of hire charge be quoted as **Rs.-24,000/- (Rupees Twenty Four Thousand)** excluding fuel and lubricants. **Payment of monthly hiring charges depends upon availability of allotment fund. Non Availability of allotment may delay the payment of monthly hiring charges.**
7. The vehicle must achieve a minimum fuel efficiency of **12K.M** per litre.
8. The details of the make and year of manufacture of the vehicle, registration no., mileage(km covered per litre) and name of the Driver, Driving license No. and period of validity should be specifically provided in the general bid information to be furnished with the quotation/Tender (Annexure-B).

**Terms & Conditions**

The following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on hire on monthly rent basis.

1. The hired vehicles during period of contract shall have all necessary valid MV documents such as valid registration certificate, Insurance certificate, pollution certificate, fitness certificate, valid contract carriage permit, proof of up to date tax payment etc. and D.L. of the driver available all the times.
2. The office (i.e ICDS Project Bhograi-R) hiring the vehicle shall not be responsible for any damage/losses caused to hired vehicles or loss of life /injury made to any person or damage to any property on account of use of hired vehicle any manner whatsoever. The hirer shall be responsible for all such litigation.
3. The hire charges to be paid for monthly basis is final but does not include cost of fuel, which is to be paid separately basing on actual consumption and as per existing government norms. All the expenditure of the vehicle towards repair, replacement of spare parts, lubricating oil of engine, gear box & differential coolant, Tyre & Tubes, Battery etc. will be borne by the bidder.
4. It shall be the responsibility of the bidder to provide a good driver and the remuneration of the driver shall be borne by the owner.
5. In case of breakdown for reasons whatsoever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle/bidder.
6. In case of the vehicle do not report regularly, the authority will be at liberty to terminate the agreement without prior notice.
7. The vehicles shall report for duty for minimum of 25 days in a month.
8. In case of emergency, the driver will have to report for duty as per the requirement. No extra payment shall be made.
09. Monthly hire charges and reimbursement towards cost of fuel (as per actual) and lubricants (as per govt. Norms) of selected bidder will be paid in every succeeding month, as per as possible within fifteen days of the submission of bills by the service provider and no advance payment will be made.

10. The vehicle shall not be more than **3 years** old from the initial registration and also in good condition during the period of contract. Vehicle older than 07 years should be replaced by new vehicles by the service provider.

11. If the services are found to be unsatisfactory, the client shall give one month notice and terminate the agreement.

12. In case the service provider intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal of service and termination of agreement.

13. If the bidder violates any of the terms of contract, Government shall forfeit the entire amount of security deposit.
